The following amendment has been incorporated in the above mentioned IFB for the Supply, Installation & Commissioning of Cuvettes Based Digital Haemoglobinometer in HLL's brand name under rate contract for 24 months.

1. SECTION VI QUALIFICATION CRITERIA

FOR

The minimum criteria to participate in this IFB are as under:

- 1. The bidder should have a minimum experience of 3 years in the supply, installation and commissioning of the product. Complete details of projects executed in last three years with relevant supporting documents from end customer must be accompanied with the Bid document
- 2. The bidder should have supplied 50% of the yearly requirement to any state or central government institutions during each one of the last three financial years FY. 2016-17, 2017-18 & 2018-19. Relevant certified documents establishing supply of equipments in last three years (Minimum 750 machines to be supplied during each one of the last three financial years to state government /central government institutions) must be submitted along with the bid. Performance certificate (minimum 5 nos.) to be submitted from government institutions who are using the equipment for at least three years.
- Bidder should have good financial background with an average turnover of 10 crores during the last three FY. 2016-17, 2017-18 & 2018-19. The bidder must submit their balance sheet, profit and loss account for last three years duly certified by chartered accountant.

MAY BE READ AS

- The bidder / Manufacturer should have a minimum experience of 3 years in the supply, installation and commissioning of the product. Complete details of projects executed in last three years with relevant supporting documents from end customer must be accompanied with the Bid document
- 2. The bidder should have supplied 50% of the yearly requirement to any state or central government institutions during the preceding three years from the date of Technical Bid Opening. Relevant certified documents establishing supply of equipments during this period must be submitted along with the bid. Performance certificate (minimum 5 nos.) to be submitted from government institutions who are using the equipment.
- 3. Bidder should have good financial background with an average turnover of 10 crores during the preceding three years from the date of Technical Bid Opening. The bidder must submit their balance sheet, profit and loss account for last three years duly certified by chartered accountant.
