HLL Lifecare Limited (HLL), Thiruvananthapuram invites sealed bids from the competent and eligible bidders to enter into the Annual Maintenance Contract (AMC) (as back to back support from OEM) for Video Conferencing installed at HLLCMO HLLKFB, HLLIFC and HITES - Noida for the period of 1 year from 01.04.2020 - 31.03.2021. Details of the items and addresses of the locations are given in **Annexure–I**. You are requested to submit your lowest offer for AMC based on the following terms & conditions.

#### **Terms & Conditions**

- 1. The respective bidder should have minimum 3 years experience in supply, installation and maintenance of Video Conferencing Equipments. For this the bidder may submit the documentary of evidence like work orders/certificate from the clients for the similar works done along with the bid.
- 2. The bidder should be authorized partner of OEM (M/s.Polycom) and Manufacturer Authorization Form (MAF) addressed to HLL should be submitted along with the bid.
- 3. The bidder should have service support centers/partners at Chennai, Kochi, and Belgaum/nearby location and Noida/New Delhi. Addresses and contact person details should be furnished along with the bid.
- 4. The bidder should have not been blacklisted by and state/central Government organizations/firms/institutions for which the self certificate stating that the bidder has not been blacklisted by any institution of the Central/state Government in past three years may please be submitted.
- 5. The period of AMC is 01st April 2020 to 31st March 2021 for all the items.
- 6. The prices should be quoted in the format for price schedule given in **Annexure II**.
- 7. Scope of AMC services:
  - (i) One preventive maintenance check should be done in every quarter (once in 3 months) on prior permission from the concerned persons of the unit.
  - (ii) Breakdown calls should be attended within 2 6 hours of intimation. Breakdown calls should be attended on holidays in case of emergency without any additional charges.

- (iii) The preventive maintenance/break down maintenance reports duly signed by the bidder's representative and concerned persons of the unit should be submitted to IT department CHO by 5<sup>th</sup> of every month.
- (iv) All the defective parts/items except plastic and consumable parts should be replaced without any additional cost.
- (v) If any defective parts/items cannot be serviced at HLL site, those items shall be taken to the contractor's site by providing the standby item, which is technically equivalent or higher to the defective item.
- (vi) We may shift some of the equipments to some other department/locations if required. In this case necessary assistance should be provided at no extra cost.
- (vii) HLL may upgrade or replace some of the items based on need. This should, however, not affect the terms and conditions of AMC.
- 8. Payment will be released either from Head office or the respective units in four installments on successful completion of AMC for the relevant three months' period on submission of the following.
  - (i) Three copies of invoice (with respective GST Number of the location)
  - (ii) Report of the preventive maintenance services carried out for the relevant three months' period.
  - (iii) Monthly report on the breakdown maintenances carried out during the period.
- 9. The bidder who requires any clarification on the tender shall notify the undersigned through e-Mail at sivakumar@lifecarehll.com. However no post bid clarification shall be entertained.
- 10. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.
- 11. No bidder shall try to influence the Purchaser on any matter relating to its bid, from the time of the bid opening till the time the Purchase order is placed.
- 12. The bids will be evaluated by taking the total amount quoted for all the items together.
- 13. AMC will be terminated prior to expiry if the services are found not satisfactory by giving one month notice period.
- 14. The AMC period may be extended at the same terms and conditions after the period of one year at the discretion of HLL.
- 15. HLL has the right to increase or decrease up to 20% of the quantity of items specified in the schedule of requirements without any change in the unit price and other terms and conditions at the time of award of contract and well as during the period of contract.
- 16.HLL reserves right to place single or multiple Purchase / Work Orders on the successful bidder based on the discretion of HLL

- 22. No fax/email bids will be accepted.
- 23. Any bids received after the deadline for submission will be rejected.
- 24.HLL shall not be liable for the delay in submission of bids after the due date specified above due to any reason including postal delay.
- 25. Any dispute arising out of the tender/bid document/ evaluation of bids/issue of purchase order shall be subject to the jurisdiction of the competent court at Thiruvananthapuram only.
