- 9. Statutory documents like licenses if any should be supplied along with the product.
- 10. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.

- 11. The supply order will be placed on the first lowest responsive bidder.
- 12. HLL will have the right to increase or decrease up to 20% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions.
