HLL Lifecare Limited has one of India's best manufacturing facility for production of both absorbable and non-absorbable surgical sutures. The installed capacity of this state of the art facility is **600,000 dozens sutures per annum**.

3. INFRASTRUCTURE

Manufacturing facility is designed as per the requirements to meet International standards in medical device manufacturing. This facility has been assessed and certified to ISO 9001:2008 & ISO 13485:2003. Manufacturing is done in Class 10000 & Class 100 clean room facilities designed as per ISO 14644 guidelines and WHO GMP.

The Suture plant is designed in an area of 300 Sq. M. The clean room facility has three separate areas for manual assembly operations, primary packing and sterile product sealing under special RH controlled conditions. The clean room is completely built with Stainless Steel panels and with self-leveling epoxy flooring to maintain Class 10000 cleanliness. The unit have a centralized storage facility having air conditioned storage area for suture raw material.

The production facility also includes facility for storage of WIP material in Nitrogen chamber specially made to ensure the quality of suture material. ETO Sterilizer is capable of sterilizing 4000 dozens of sutures/cycle. Also a nitrogen generator capable of supplying 99.99% pure nitrogen required for the sterilization process is attached to the manufacturing facility.

Unit have in-house facility to carry out all Physical, Chemical and Microbiological tests as per USP standards required for suture production. 24 Hour power back up with 1000KVA Genset is also available.

The principal raw materials are imported from reputed suppliers from Korea, Brazil, Germany & UK. All critical machineries in production are imported from USA & Italy. The unit engages highly skilled and specially trained manpower for manufacture of sutures.
