- 2. Experience of having successfully completed similar works of following value during the last three years ending 30/04/2025, Work order and work completion certificate to be enclosed.

- 1. The concrete mix will be designed for minimum workability as specified in **paragraph** 7 of **IS-456-2000**. The slump test **shall** be carried out as per **IS-1199**.
- 2. In the designation of a concrete mix, the letter "M" refers to the mix and the number **specifies** the characteristic compressive strength of a **15 cm cube** at 28 days, expressed in N/mm².
- 3. **Grade of Concrete** The compressive strength of various grades of concrete shall be as follows:

- 4. For each mix, a set of six cubes shall be made from each of three random batches. Three cubes from each set of six shall be tested at the age of 7 days, and the remaining three cubes shall be tested at 28 days. The cubes shall be made, cured, transported, and tested strictly in accordance with specifications. The average strength of nine cubes at the age of 28 days shall exceed the specified target mean strength for which the mix has been approved. The evaluation of the test will be done as per IS-456-2000.
- 5. **Test Result Samples** The test results of a sample shall be the average strength of **three specimens**. The **individual strength** shall not **deviate** by more than **± 15%** of the average.
- 6. In case of rejection of concrete due to unacceptable compressive strength, governed by the "Standard of Acceptance", the work for which the samples have failed shall be redone at the contractor's cost.
- 7. All tests shall be carried out at the contractor's costas per instruction of engineerin charge
- 8. The rate includes the cost of materials and labor involved.
- 9. The contractor shall not be paid extra for admixtures, fibers added, etc.
