3. Consignment shall reach at destination on or before the days mentioned in tender from date of issue of LR.
4. All interested parties shall remit EMD of INR **25,000/-** through DD/NEFT/RTGS. DD shall in favor of HLL Life care Limited, payable at SBI Nippani - 591 237. 6. All statutory deduction shall have borne by contractor / transporter.

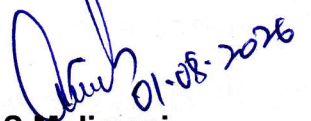

12. Bids received after the due date for the submission will not be considered.

It shall be the sole responsibility of the transporter / contracting carriers to ensure adequate protection to all the materials from sun, rain, mechanical damages and all other hazards and satisfactory delivery of the consignment to the consignees within the stipulated time and any damage and shortage recover from the transporter.
14. If the transporter fails to provide the vehicles within the time given, company reserves the right to engage vehicles from other source at the cost and risk of transporter.
15. Please note that there is no post tender negotiation except with L1. Hence kindly offer your most competitive rates.
