1.3.1 Brief Scope

The project involves the Design, Engineering, Supply, Installation Testing and Commissioning of STP for PMSSY- Phase III projects at 9 locations on turnkey projects

The work shall, inter-alia, include the following:

- i. STP should be designed for mechanized operation wherever practical for the operator's safety, health and hygiene.
- i. The Project is turn-key job and it will be the responsibility of the bidder to carry out basic and detailed design, engineering, except civil construction, equipment supply, installation, testing and commissioning and handing over a completely functional unit complying with Central Public Health and Environmental Engineering Organisation (CPHEEO) Manual/Guidelines and state PCB norms and with all necessary components
- ii. Design of all civil structures for the system.
