### **TERMS & CONDITIONS**

# TERMS AND CONDITIONS FOR HIRING OF MINI BUS FOR OFFICIAL USE ON CONTRACT BASIS

- 1) The tenderer must be owner of vehicles / Registered firm (s) / Authorized Agent(s) / Individual. In case of Firm/Company the vehicle can be owned by the Firm/Company. The vehicle should have a valid Registration and Permit to run Passenger Vehicle Service in Kerala State, Thiruvananthapuram, during the Contract period. Copies of the RC books of Minimum 2 vehicles, to be enclosed along with the tender to prove the ownership and year of Registration. Vehicle shall be in good condition and road worthy.
- 2) Only the contractor who is having 2 vehicles under his ownership or having authorization from the Registered Owner of the vehicle to participate in this tender along with copies of RC book is eligible to participate in the tender.
- 3) An **EMD of Rs. 10,000/- (Rupees Ten thousand only)** in the form of Demand Draft in favor of HLL Lifecare Limited, Thiruvananthapuram payable at Thiruvananthapuram should be accompanied along the tender. Tender without EMD will be summarily rejected.
- 4) Successful bidder shall submit Security Deposit of 3% Order Value, subject to a maximum order value of Rs.1,00,000/- (Rupees One Lakhs Only) in the form of Demand Draft in favor of HLL Lifecare Limited, Thiruvananthapuram payable at Thiruvananthapuram or Bank Guarantee from any Schedule bank. The EMD remitted by the successful bidder will treated as Security Deposit and the balance amount will be needs to be paid within seven days of finalization of tender and the same would be returned after the successful completion of the Contract.
- 5) EMD remitted will be forfeited if the successful tenderer withdraws after opening the tender.
- 6) The Contractor shall provide the vehicle along with driver having valid license and badge, if any, good vision and good character. The vehicle provided should be in good running condition.
- 7) The rates quoted should include wages to the driver, cost of fuel, maintenance charges, any other charges for providing the vehicle in good running condition.
- 8) The insurance coverage (comprehensive), GST / Income tax and all other statutory payments, supply of fuel, lubricants etc for the vehicle and the maintaining of the vehicle in good condition and payment to the driver and compliances of all laws and rules applicable in owning, maintaining and providing the vehicle on contract shall be the responsibility of the contractor.

- 9) The contractor should take necessary third party insurance coverage for the vehicle and that any accident or loss or damage that happens either to the vehicle or to the driver or any persons shall be taken care of by the contractor. The contractor alone will be liable for compensation if any to be paid and the company shall not have any liability in this regard.
- 10) In case of any accident, the contractor will be solely liable and HLL will not have any liability for the damages or compensation.
- 11) The contractor shall bear the cost of all the maintenance work of the vehicle provided. In case, the vehicle cannot be made available due to breakdown, Inspection etc., the contractor shall make alternative arrangements to provide substitute vehicle of the same category failing which the amount born by the company to arrange a vehicle, will be recovered from the bill of the contractor.
- 12) The drivers and vehicles should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the contractor.
- 13) Payment will be made by monthly basis on presentation of Monthly bill along with copies of Log book / Copies of Trip Sheet forms of both the vehicles, duly certified by HR Department, AFT. The contractor should also ensure that wages not less than the minimum wages applicable is paid to the driver. Certificate to this effect shall be submitted by the contractor along with the monthly bill. PF & ESI coverage as applicable shall be the responsibility of the contractor.
- 14) The payment would be released on monthly basis within 30 days on actual trip basis.
- 15) The party has to submit their rate in the format attached in the Price Bid. Statutory levies if any such as TDS, GST TDS, etc. should be deducted from the bills.
- 16) Contractor will have to provide alternate vehicle in the event of break down while the vehicle is in use. If not provided, **HLL Lifecare Limited** will arrange its own alternate arrangement means of conveyance. In such cases, the cost of transportation arranged will be recovered from the contractor's monthly bill/Security Deposit.
- 17) In case of failure in providing the vehicle for any reason, deduction will be made from his monthly bills, as penalty, in following manner;
  - a) Failure to provide the vehicle per trip / per day actual expenses incurred for arranging alternate arrangement and all other losses, if any by HLL will be deducted from Contractor's monthly bill.
- 18) Failure to supply vehicles continuously for a period of seven days will be treated as breach of contract and the Security deposit will be forfeited.
- 19) The meter indicating the kilometer should be accurate and in working condition as per the regulation of the Regional Transport Authorities concerned. The kilometer reading will be recorded at the factory premises ie. Kilometer at the time of going out of factory and at time of returning to factory.

- 20) Log book will be kept in Vehicle under the custody of the driver for recording the distances of journeys performed and will be verified on daily basis for settlement of monthly bill.
- 21) The driver shall fill in the Trip Sheet forms made available from the Security Gate.
- 22) The contract will be for a period of **Two** years.
- 23) On awarding the contract, the contractor shall execute an agreement with HLL Lifecare Limited to the effect in a stamp paper equivalent to Rs.200/- (Rupees Two Hundred Only). ### **INDEMINITY CLAUSE:**
