## 1. NOTICE INVITING TENDER

Invitation of Bids for selection of NABL ACCREDITED LABORATORIES for performing Inter-Laboratory-Comparison (ILC) of samples for HINDLABS diagnostics centers in Maharashtra.

#### **ABOUT US**

HLL Lifecare Limited (HLL) is a public sector undertaking under the administrative control of the Ministry of Health &Family Welfare, Government of India. HLL's purpose of business is "to be a globally respected organization focusing on inclusiveness by providing affordable and quality healthcare solutions through continuous innovations. In its quest to become a comprehensive health care solutions provider, HLL had diversified into hospital products, healthcare and retail services, while nurturing its core business of providing quality contraceptives.

The Healthcare Services Division of HLL provides Medical Diagnostic Services (Laboratory and Imaging) and other facilities like Wellness Clinic/Polyclinic to partner institutions in a PPP model. Our first center in association with CGHS started functioning since February 2008 in New Delhi. The Healthcare Services Division (HCS) of HLL has established network of laboratories across the country, especially with a very large network in the States of Maharashtra, Assam and Uttar Pradesh for State Government projects.

HLL has established 132 HINDLABS Diagnostics Centers across the State of Maharashtra, for implementing the Free Diagnostics Scheme of Government of Maharashtra. In HINDLABS, quality stands on priority and undergoes various quality programs which include Inter-Laboratory-Comparison (ILC). As part of this, 1% of samples per day shall be sent to an NABL accredited laboratory for testing. HLL currently implement the ILC program through the outsourcing partner laboratories. But in order to avoid the factor of 'conflict of interest' HLL is planning to undertake the ILC program exclusively with those labs other than our existing outsourcing partners.

This tender is invited for selection of NABL Accredited laboratory for performing Inter-Laboratory-Comparison (ILC) of samples for all the HINDLABS Diagnostics Centers across the Maharashtra state under the NHM project.



## 2. SCOPE OF SERVICE

The Laboratories selected for ILC shall carry out the following:

- Shall collect the samples for ILC from the respective labs once in a week as per the locations mentioned in Annexure-B.
- Shall ensure the transportation of samples from HINDLABS to the testing labs are
  done safely and under the required temperature so that the samples shall meet
  the quality requirements for acceptance and testing.
- Shall be able to make HINDLABS barcode compatible to the testing lab software so that comparison can be done by HINDLABS team.
- Shall able to perform tests as per the test menu in Annexure-C.
- Shall able to deliver the reports as per the TAT in Annexure-C. In the event there is any delay in TAT, 10% of the test cost for each day will be deducted for the particular test.
- Shall able to provide the software interface which facilitates the registration and transfer the reports to the LIS used by HINDLABS.
- Shall provide the analytical reports as per the format given by HLL as per the requirement.
- Shall provide the QC data as per HLL's requirements.
- Shall help HINDLABS to standardise the biological ranges if any requirement arise to compare the results.
- Shall submit the SOP for sample collection, transportation and reporting of the samples.

## **EARNEST MONEY DEPOSIT (EMD)**

- EMD: All parties shall submit an EMD of Rs. 2,00,000.00 as bank guarantee along with the bid in the shape of Bank Draft / Bankers cheque from any Schedule Bank in favour of "HLL Lifecare Limited" payable at Trivandrum.
- It may be noted that no tendering entity is exempt from deposit of EMD. Tenders submitted without EMD shall be rejected.
- The EMD of unsuccessful bidder will be returned to them without any interest, after conclusion of the resultant contract. The EMD of the successful bidder will be returned without any interest, after receipt of performance security as per the terms of contract.
- EMD of a bidder may be forfeited without prejudice to other rights of the purchaser, if the bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender or if it comes to notice that the information /documents furnished in its tender is incorrect, false, misleading or forged. In addition to the aforesaid grounds, the successful bidders' EMD will also be forfeited without prejudice to other rights of purchaser, if it fails to furnish the required performance security within the specified period.

## IV) Preparation of bids

The bids shall be made in TWO SEPARATE SEALED ENVELOPES as follows:

- (1) The first envelopes shall be marked in bold letter as "TECHNICAL BID" which shall include the following in addition to the eligibility criteria:
  - Earnest Money Deposit (EMD)
  - Profile of the Organization
  - Organization Structure
  - Memorandum of Association/Articles of Association.
  - PAN/TIN Card of the firm
  - Authenticated copy of the certificates of incorporation/registration of the organization
  - Authenticated copy of annual accounts for the last three years



- Authorization letter in the company letterhead authorizing the person signing the bid for this tender
- Work orders of the cited projects
- Details of NABL Accreditation & EQAS
- Details of Collection centers and labs along with address and contact numbers
- Order copy in providing laboratory service for Government projects
- Decision taken by the Board /authorized committee of the organization to submit the tender published by HLL.
- Provide service for the contract period stipulated by HLL or until terminated earlier by HLL.
- (2) The second envelope shall contain the financial proposal and shall be marked in bold letters as "FINANCIAL BID". Prices shall be quoted in the prescribed format enclosed at "ANNEXURE-A" as per scope of work / service to be rendered.

## V) Financial Bid Submission

- The rates are to be quoted as 'PERCENTAGE DISCOUNT FROM CGHS (BASE)

  TEST RATES. CGHS (NABL) rates for the tests is enclosed as Annexure C.
- The offered discount shall be same for all the tests in the list.
- The NABL Accredited laboratory who is offering the highest percentage of discount from the NABL rate shall be selected as the party for performing Inter-Laboratory-Comparison (ILC) of samples for all the HINDLABS Diagnostics Centers across the Maharashtra state.

# VI) Evaluation of Bid

**Scrutiny of Bids:** The Bids will be scrutinized to determine whether they are complete and meet the essential and important requirements, conditions and whether the



bidder is eligible and qualified as per criteria laid down in the Bid Enquiry Documents. The bids, which do not meet the aforesaid requirements, are liable to be treated as non-responsive and may be ignored. The decision of the purchaser as to whether the Bidder is eligible and qualified or not and whether the bid is responsive or not shall be final and binding on the bidders. Financial bids of only those bidders, who qualify technical bid, will be considered.

**Infirmity / Non-Conformity:** The purchaser may waive minor infirmity and/or non-conformity in a Bid, provided it does not constitute any material deviation. The decision of the purchaser as to whether the deviation is material or not, shall be final and binding on the bidders.

**Bid Clarification:** Wherever necessary, the purchaser may, at its discretion, seek clarification from the Bidders seeking response by a specified date. If no response is received by this date, the purchaser shall evaluate the offer as per available information.

The financial bid shall be evaluated based on the lowest percentage offered by the party for managing the activities in the laboratories to maintain the Turn Around Time for all the tests.

HLL may reject all proposals if they are found to be unresponsive or unsuitable if they represent major deficiencies in complying with the requirements.

The selected Laboratory shall commence the services within 7 days of issue of LOI by HLL.

## VII) Mode of submission of BID

Documents in electronic form will not be accepted.

The documents eligibility criteria, EMD and other relevant documents may be submitted in a sealed envelope marked in bold letter as "TECHNICAL BID"

The second envelope shall contain the financial proposal and shall be marked in bold letters as "FINANCIAL BID".



The two envelopes containing both technical and the financial bid shall be put in a bigger envelope, which shall be sealed and superscripted with "TENDER NO 01 - HLL/SD/CHO/HCS/TENDER 01 dated 05<sup>th</sup> October 2020" and marked as "Tender for selection of NABL Accredited Laboratory for performing Inter-Laboratory-Comparison (ILC) of samples for all the HINDLABS Diagnostics Centers across the Maharashtra state under the NHM project".

The offer shall contain no interlineations or overwriting except as necessary to correct errors, in which cases such correction must be initialed by the person or persons signing the Bid. In case of discrepancy in the quoted prices, the price written in words will be taken as valid.

The last date for submission of the bid is 19<sup>th</sup> October 2020. The bids submitted after the stipulated time shall not be considered for evaluation and shall be rejected.

## VIII) TERMS & CONDITIONS

## 1. General Instructions to Bidders.

- a) Conditional offers are liable for rejection.
- b) The Bidders should give clause by clause compliance of tender with references to supporting documents; otherwise the offers are liable for rejection.



- c) The parties shall submit the SOP before implementation.
- d) The tenderers shall quote for all the labs associated with the project across Maharashtra.
- e) The prices /percentage quoted shall be firm and inclusive of all taxes and duties. The prices shall be quoted only in the format given as Annexure.
- f) The quoted price/percentage shall be valid for a period of 5 years.
- g) The Bid shall be submitted before the last date and time as mentioned in this tender/bid document. Late tenders/bids shall not be considered.
- h) The laboratory is responsible for maintaining the quality of testing and HLL (Hindlabs) shall do monthly quality audit as per QA policy.
- i) While the Tender has been prepared in good faith, HLL does not make any commitment or warranty, express or implied, or accept any responsibility or liability, whatsoever, in respect of any statement or omission herein, or the accuracy, completeness or reliability of information contained herein, and shall incur no liability under any law, statue, rules or regulations as to the accuracy, reliability or completeness of this request, even if any loss or damage is caused by any act or omission on its part.
- j) Organizations are requested to keep the information and details strictly confidential. We are looking for your support and co-operation in getting fully responsive Expression of interest.
- k) HLL shall not be responsible for any expense incurred by Parties in connection with the preparation and delivery of their bids and other expenses.
- l) HLL reserves the right to reject any or all the Tender without assigning any reason thereof.
- m) The process of inviting tender is for ascertaining various options available to HLL. After evaluation / examination of the offers, HLL may at its sole discretion decide further course of action.



- n) HLL reserves the right to deal with the proposal in any manner without assigning any reasons for the same. The decision of HLL in this regard shall be final.
- o) All other terms and conditions mentioned in the tender is applicable to the Laboratory selected.
- p) Any additions/amendments to this tender shall be uploaded in HLL's website www.lifecarehll.com

#### 2. Performance Security

- a. The successful bidder shall furnish a performance security in the form of a Bank Guarantee issued by a scheduled/nationalized bank in favour of HLL Lifecare Ltd for Rs.5.0 lacs. (Rupees Five Lakhs Only). The BG format shall be issued to the successful bidder by HLL.
- b. This shall be submitted within 15 days (minimum) of receiving of Notice for Award of Contract, failing which the EMD may be forfeited and the contract may be cancelled.
- c. The Performance security shall be liable for forfeiture, wholly or partly, in case of Violation of any of the terms and conditions of the contract and deficiency in service as agreed.
- d. The performance security will be released without any interest, within 60 days after the successful completion of the contract.

## 3. Bid Validity

The bids shall remain valid for acceptance for 180 days from the date of opening of Bids and the contract will be valid for duration of 5 years.

#### 4. Delivery Period

The successful bidder shall commence the proposed services within 7 days from the date of issue of LOI/work order by HLL Lifecare Ltd. The successful bidder shall execute a detailed agreement with HLL in the format proposed by HLL



within 15 days from the date of issue of HLL's work order along with submission of Performance Security.

## 5. Payment Terms

- a) The payment will be released on a monthly basis within 45 days from the date of receipt of Invoice by HLL Lifecare Ltd.
- b) Payments shall be released after making the income tax deduction at source (TDS) at the applicable rates.

## 6. Liquidated Damages

- a. If the successful bidder fails to execute the contract with in the stipulated time, there shall be levied liquidated damages equal to 0.5 % of the contract value for each week of delay till the delay continues, up to a maximum limit of 5% of the contract.
- b. The service provider will be penalized if they fail to deliver the test reports within the defined time mentioned in the tender/bid. In case of increased TAT (Turn around Time) the service provider will be penalized at the rate of 25% per test if the delay exceeds one hour.

#### 7. Arbitration

- a. If a dispute or difference of any kind between HLL Lifecare Ltd and the service provider in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual discussions.
- b. If the parties fail to resolve the dispute or difference by such mutual consultations within 21 days of commencement of consultations, then either HLL Lifecare Ltd or service provider may give notice to the other party of its intention to commence arbitration, as hereinafter provided.
- c. The applicable arbitration procedure will be as per the arbitration and conciliation. Act, 1996 of India. In the event of Arbitration, the dispute or difference shall be referred to the sole arbitration of an officer to be



appointed by HLL Lifecare Limited venue of Arbitration shall be Thiruvananthapuram.

#### 8. Termination of Contract

HLL Lifecare Ltd may terminate the contract, if the successful tenderer/bidder withdraws its tender/bid after its acceptance or fails to submit the required performance security or fails to fulfil any other contractual obligations.

In that event HLL Lifecare Ltd shall have the right to avail the required services from the next eligible bidder and the extra expenditure on this account shall be recoverable from the defaulter.
