- 2. Mixed quotations will not be considered for acceptance.

PLEASE NOTE THAT PRICES SHOULD NOT BE INDICATED IN THE TECHNO- COMMERCIAL BID. THE PRE-QUALIFICATION DOCUMENTS AS REQUIRED IN TENDER DOCUMENT SHOULD INVARIABLY BE ACCOMPANIED WITH THE TECHNO COMMERCIAL BID.

- 5. The tenderers should give rates, including taxes, if any, and levies, packing forwarding and delivery charges. HLL IS NOT AUTHORIZED TO ISSUE 'C/D FORMS' Tender not confirming to these requirements shall be rejected and no correspondence will be entertained whatsoever.
- 6. <u>THIS TENDER DOCUMENT AND SUBSEQUENT RATE CONTRACT (S) WITH THE APPROVED</u> <u>FIRM (S) IS NON-TRANSFERABLE.</u>
- 7. Prices should be inclusive of delivery charges and unloading charges at Free Generic Pharmacy, AIIMS /HLL warehouse at Delhi as specified by HLL
- 8. The Tender forms be clearly filled in ink legibly or type written giving full address of the tenderers. The tenderers should quote in figures as well as in words the rates/amount tendered by him/them. Alterations/over-writing unless legibly attested by the tenderer, shall disqualify the tenders. The tenders should be signed by the tenderers himself/themselves on his/their behalf (Authorization may be enclosed, if applicable).
- 9. THE FORWARDING LETTER/UNDERTAKING **(SCHEDULE'A')** DULY SIGNED SHOULD INVARIABLY BE RETURNED ALONG WITH QUOTATIONS FURNISHED, FAILING WHICH THE TENDER SHALL BE REJECTED.
- 10. The tenderers should take care that the rates and amounts are written in such a way that interpolation is not possible, no blanks should be left which would otherwise, make the tender redundant.
- **11.** The quotations shall be valid for a period of 1 year from the date of opening of Price Bid.
- 12. The firm is required to submit its satisfactory performance certificate in the similar field of the past reputation for supply of Generic Drugs/Pharmaceutical Products on day to day basis, from alike organization(s) on their letter head.
- 13. The firm has to provide the copy of valid retail drug license issued by the State Authority.
- 14. The tenderer shall furnish following certificates invariably along with technical bid, as applicable otherwise quotation shall be summarily rejected:-
 - (a) A declaration by the proprietor of the firm, in case the firm is proprietorship firms on non-judicial stamp paper of worth Rs. 100/- duly attested and
 - (b) A self attested copy of partnership deed duly registered by the Registrar of Firms, in case of partnership firm.
 - (c) A self attested copy of Article of Association & Memorandum with constitution of firm and guidelines, in case of private limited firm with name, photo & signatures of all directors.





15. Risk purchase:

a) In case of non supply to Stores within the due date i.e. within the date of delivery, the VP Marketing, HLL Lifecare Ltd., will have the right to impose penalty, as deemed fit, to resort to risk purchase from open market in full or part thereof at his/her discretion, his/her decision shall be final and binding.

b) If L1 or any other party defaults (fails to deliver goods on time) then the purchaser reserves the right to purchase the goods from L2 or higher bidder or from market at the risk and cost of supplier. If the purchase happens at a price higher than the ordered rates, the purchaser shall have the right to claim the difference upon which order was originally placed and supplier will be under obligation to pay the same. The purchaser has the right to recover the same from the performance security if the supplier does not make the payment.

- 16. **Inspection:** Vendors have to submit internal Lab Test Reports stating that the products supplied is of standard Quality. However, the purchaser reserves the right to sample check the consignment at the time of delivery. In case of any failure, NABL Report submitted on behalf of HLL Lifecare Limited will be considered for final validation. No payments shall be made for rejected Stocks. Rejected items must be replaced by the tenderers immediately within 2-3 days of intimation of rejection by HLL at their own cost and replace immediately with fresh stock of standard quality. In case these are not removed these will be auctioned at the risk and responsibility of the suppliers without any further notice and the purchaser reserves the right to purchase the goods from L2 or higher bidder or from market at the risk and cost of supplier.
- 17. Any statutory levies imposed by the Govt. of India from time to time will be authorized extra on demand with adequate proof thereof.
- 18. Force majeure will be accepted on adequate proof thereof.
- 19. The VP Marketing, HLL Lifecare Ltd, shall be final authority to reject full or any part of the supply which is reconfirming to the specification and other terms and conditions.
- 20. Tenderers submitting tenders would be considered to accept all the terms and conditions. No enquiries, verbal or written, shall be entertained in respect of acceptance or rejection of the tender. Tenderer should sign all the pages as a token of acceptance of all the terms and conditions.
- 21. Any action on the part of the tenderer to influence anybody in the said Organization will be taken as an offence, he will not be allowed to participate in the tender enquiry and their offer will not be considered.
- 22. The tenderer shall furnish a declaration that the firm has not been blacklisted in the past by any government/Private institution and there is no vigilance/ CBI case pending against the firm/ supplier.





- 23. The court at Delhi will have the jurisdiction to try any matter, dispute or reference between the parties arising of the contract. It is specifically agreed that no court outside and other than Delhi Court shall have jurisdiction on the matter.
- 24. If the tenderer gives a false statement on any of the above information, the firm/ supplier will not be considered and their quotation/tender shall be deemed to be rejected.
- 25. Payment of the approved vendor for supply shall be made only through electronic clearing system.
- 26. It is clarified that bidders should quote their best rates with respect to all Generic Drugs/Pharmaceutical Products for supplies to be made under agreement. The quoted offer shall remain valid for the entire duration of the appointment of wholesaler/Drug stockiest, i.e. for 1 year from the date of contract agreement and extendable up to 6 months as deemed fit by the purchaser.
- 27. In case of proprietary Drugs/Pharmaceutical Products etc. which are available only with the manufacturing company imported by sole agent and are not freely available in the market these items should be supplied along with product of purchase from the sole agent/authorized dealer.
- 28. The purchaser does not pledge himself to accept the lowest or any Bid and reserve to himself the right of accepting the whole or any part of and the bidder shall supply the same at the quoted rates. The bid is required for whole or any part or portion (either for generic or branded items or both).
- 29. The order will be placed on Weekly/ Fortnightly/Monthly basis.

Other terms and conditions of the tender

- 1. The lists for indent of Generic Drugs/Pharmaceutical Products shall be given to the suppliers within 2 working days of raising Indent. In emergency, the firm has to supply the required item within 2 days of telephonic order and services have to be provided on all six days of a week.
- 2. The wholesaler/Drug stockiest have to maintain availability of Generic Drugs/Pharmaceutical products on the counter.
- 3. The vendors shall provide the best rates to be quoted.
- 4. For items which are imported and not readily available, firm will have to produce proof of purchase and rate charged by sole agent/ authorized dealer of the item. However if firm failed to supply the item then special penalty of Rs. 500/- per item in each instance will be levied.
- 5. The firm has to submit the bills on monthly basis. Please supply the goods alongwith two copies of the bills marked "**Original**" and "**Duplicate**", three copies of challan and analysis reports of their quality control lab of all the batches of the products to the consignee.
- 6. **Percentage of supply:** The selected firm will have to supply at least 90% of all the indent from Free Generic Pharmacy.





- 7. The firm shall supply the generic salts as indented. However, if the same generic salt cannot be supplied, then substitute/brand should be from reputed firm with explicit prior concurrence of HLL indenting officer.
- 8. Quantity of Item: The firm will have to supply the full quantity as indented for all items. In case they provide short or substitute supplies without concurrence, these will be considered as "non-supply" and a sum penalty @ Rs.100/- per item except in case of imported / not readily available items & in case of non supply of these items, penalty of Rs. 500/- per item in each instance be imposed. The penalty will be calculated on the basis of "non supplied" items below the stipulated 90% limit on a daily basis and will be imposed as per the billing cycle.
- 9. The selected firm has to sign a contract to supply the Generic Drugs/Pharmaceutical Products for a period of one year as per term of tender from the date of acceptance. The services will be reviewed periodically, in case of unsatisfactory supplies at any time contract is liable to be cancelled without serving any notice and the firm will be banned to participate in the tender for further 02 years.
- 10. This contract will be applicable for indents raised, however HLL reserves the right to purchase required items from other sources in case the same item is available at competitive price. HLL also reserves the right to enter into a parallel rate Contract in case the same item is available at competitive price.
- 11. VP Marketing, HLL Lifecare Ltd, AIIMS, New Delhi or his representatives can accept/ reject any quotation without assigning any reason. Any correspondence in this regard will not be entertained.
- 12. Techno Commercial Bids of only the vendors shortlisted from the Technical Bids will be opened in the presence of the representatives on a specified date and time to be intimated to the respective vendors. <u>Those vendors failed to submit pre-qualification certificates</u> will be summarily rejected and no correspondence will be entertained in this regard.
- 13. The vendor has to replace non moving goods and near expiry drugs before 6 months of expiry as per the communication given by the purchaser. The purchaser reserves the right for replacement of damaged goods; the vendor has to replace the damaged goods supplied within specified time period. In case the vendor fails to replace within specified time period, the purchaser may impose penalty as deemed by VP Marketing, HLL Lifecare Limited.
