Terms & Conditions

- 1. The respective bidder should have minimum 3 years experience in Antivirus implementation. For this, the bidder can submit the documentary evidence of the following along with the bid.
 - a) The copies of Supply / Work Orders for the similar kind of items for the past three years.
 - b) Certificate from at least three clients for the similar works done.
- 2. The bidder should provide latest endpoint software version of OEM and the same should be compatible with Windows 10 OS Version.
- 3. Periodic updates from OEM should be available at free of cost during the support period.
- 4. The prices should be quoted as per the format for price schedule enclosed as **Annexure 1.**
- 5. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser accordingly.
- 6. The bids will be evaluated by taking the total amount for all the items.
- 7. The supplier has to supply the product with license at Head office and necessary support should be provided for installation at respective locations.
- 8. The Authorization Letter from the OEM of the product quoted should be submitted along with the bid.
- 9. The prices quoted shall be valid for a period of 90 days from the date of opening of bids.
- 10. The items should be delivered within **2 weeks** from the date of placement of order.
- 11. Penalty at 0.5% per week's delay subject to maximum of 5% is applicable for delayed delivery.
- 12. Necessary documentations/CDs/DVDs are to be supplied along with the product.
- 13. Statutory documents like licenses if any should be supplied along with the product.
- 14. Bids should be clear in all respects and those with ambiguous and conditional clauses shall be summarily rejected.
- 15. The supply order will be placed on the first lowest responsive bidder.

- 16. The bidder who requires any clarification on the tender shall notify the undersigned through e-Mail at sivakumar@lifecarehll.com. However no post bid clarification shall be entertained.
- 17. No bidder shall try to influence the Purchaser on any matter relating to its bid, from the time of the bid opening till the time the Purchase order is placed.
- 18. Necessary support should be provided as and when required within 2 Hrs of intimation of problem.
- 19. HLL will have the right to increase up to 50% of the quantity of licenses specified in the schedule of requirements without any change in the unit price or other terms and conditions during one year period.
- 20. Payment will be released within 30 days from the date of delivery and installation of the items.
