- 7. The company reserves the right to club or split the items of works, change the qualifying criteria at their discretion and to reject or cancel the Invitation for bids without assigning any reason thereof.
- 8. All the debris created by the demolition of the wall and floor has to be disposed off by the contractor at his own cost.
- 9. The contractor shall visit the site also and make judicious assessment of the extent of the work before quoting the rate. Submission of the tender implies that the contractor has read IFB document and has made himself aware of the scope and specifications of the work/service to be done, local conditions and other factors having a bearing on the execution of the work/service.
- 10. The safety of the workers engaged for the civil work shall be the sole responsibility of the contractor and necessary safety precautions shall be taken during the execution of the work. Demolishing the compound wall shall be carried out without causing any nuisance or safety concern to the public.
- 11. HLL reserves the right to accept or reject any tender at any time, without assigning any reason or incurring any liability to the applicants. In case any doubt or dispute is arising out and in relation to this, the decision of the **Unit Chief -IFC** will be final and binding on all the Tenders.
