Payment terms

Payment shall be made in Indian Rupees as specified in the contract in the following manner:

a) On delivery:

75 % payment of the contract price shall be paid on receipt of goods in good condition and upon the submission of the following documents:

- (i) Four copies of supplier's invoice showing contract number, goods description, quantity, unit price and total amount;

- (ii) Consignee Receipt Certificate as per in original issued by the authorized representative of the consignee;
- (iii) Two copies of packing list identifying contents of each package;
- (iv) Inspection certificate issued by HLL.
- (v) Certificate of origin.

b) On Acceptance:

Balance 25 % payment would be made after satisfactory completion against 'Final Acceptance Certificate' of goods/equipments to be issued by the consignees and endorsed by HLL subject to recoveries, if any, either on account of non-rectification of defects/deficiencies not attended by the Supplier or otherwise.

Other Conditions

1. Warranty should be for minimum 2 years from the date of acceptance of Pharmaceutical Refrigerator and the Warranty has to be given in the name of client.

Performance Security

2. Within Fifteen (15) days from date of the issue of purchase order the successful bidder, shall furnish performance security for an amount equal to ten percent (10%) of the total value of the contract, valid up to sixty (60) days after the date of completion of all contractual obligations by the supplier, including the warranty obligations.
3. Demo of equipments and sample of instruments should be arranged when asked for
4. Earnest Money of Rs. 12,000/- has to be submitted along with the tender in the form of a Demand Draft/ Fixed Deposit Receipt (FDR) of a scheduled bank issued in favour of HLL Lifecare Limited, Thiruvananthapuram which should be placed in a separate sealed cover marked "Earnest Money" shall be submitted along with the tender.
5. The rate quoted should be inclusive of all taxes, duties, transport, loading and unloading up to consignee site.
