### **Minimum Eligibility criteria for qualifying**

1. The contractor should have minimum 2 years of experience for supply of manpower to reputed industries. Experience in PSU will be added qualification.
2. The contractor should have executed the contract not less than Rs.50.00 lakhs during the year 2024-2025.
3. The contractor shall possess a valid Contractor Licence issued by the Competent Authority under the applicable labour laws governing contract labour, including the Contract Labour (Regulation and Abolition) Act, 1970, or the Occupational Safety, Health and Working Conditions Code, 2020 and the rules made thereunder, as applicable from time to time.
4. The contractor should have separate PF, ESI and GST establishment code in their name.
5. EMD, Experience and turnover is applicable as per MSME Act. For MSME certified bidders.
6. The tenderer shall have an office located within a radius of 100 km from HLL Lifecare Ltd., Kanagala, Hukkeri Taluk, Belagavi District, Karnataka – 591225, and shall submit valid documentary evidence as proof of the office address.

**Copies of the above certificates shall be produced as a proof along with tender document.**

### **NATURE OF WORK**

Contractor shall deploy workers at oral contraceptive pills manufacturing plant which includes compression of steroidal granules, de-ducting of tablets, tablet inspection, de-foiling and any other departments work as per requirement. However their services will be utilized in other area in absence of work at Oral Contraceptive pills manufacturing plant.

However Management reserves the right about providing manpower having different qualification etc. other than mentioned above. Number of manpower also may be reduced / increased on need basis.

### Procedure for deciding L1 party

Minimum wages applicable as per Central Govt. notification for the deployed workmen will be fixed by the company along with statutory requirements.

Tenderer has to quote only 'Service Charges' per man day which shall include Administration overheads, Uniform Expenses, Safety Shoe, and Payment of Supervisory Staff, Profit margin, statutory payments (except ESI & PF) and all other charges etc.

### **Specific Terms and conditions**

1. Workers, who are medically and physically fit and having qualification of Below SSLC / SSLC / ITI / Diploma / Graduate / Post Graduate etc. and between the age group of 18 to 60 years, are required to be deputed for the work, however management reserves the right to relax the minimum qualification for experienced candidate on need basis. Based on the qualification, experience and performance Management will categorise the labours in unskilled / semi-skilled and skilled category.  
Workers deployed need to attend the work in First, Second and General Shift as per the requirement of the company.
2. Every contract workmen shall be allowed to take a weekly-off per week after 6 days of continuous work
3. The contractor shall give list of workmen along with qualification certificate in original and residence proof (Aadhar Card) to Officer in charge to get list approved before commencement of work. Only the workers in the approved list shall be permitted for work.
4. In order to keep better performance and the production output, the workmen deployed by the contractor shall not be changed frequently
5. The contractor has to submit medical fitness certificate of all employees to be deployed before commencement of work and medical test / checkup reports after every six months from the deployment.
6. None of the workmen shall be engaged for more than six manday in a week

## GENERAL INSTRUCTIONS TO BIDDERS

5. The bids shall be opened at HLL Lifecare Limited, Kanagala – 591 225 in the presence of the Bidders/their authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
6. More details can be had from the above Office during working hours. The Tender Inviting Authority shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the Bidder during the above tender process.
7. A firm/bidder shall submit only one bid in the same bidding process. A Bidder (either as a firm or as an individual or as a partner of a firm) who submits or participates in more than one bid will cause all the proposals in which the Bidder has participated to be disqualified.
8. Joint ventures or Consortiums of two or more registered bidders are not permitted.

10. **Opening of Technical Bid and Bidder short-listing:** The technical bids will be opened, evaluated and shortlisted as per the eligibility and technical qualifications. 13. HLL Lifecare Limited does not bind them to accept the lowest or any bid or to give any reasons for their decisions which shall be final and binding on the bidders.
14. The HLL Lifecare Limited reserves to themselves the right of accepting the whole or any part of the tender and bidder shall be bound to perform the same at his quoted rates
15. In case, it is found during the evaluation or at any time before signing of the contract or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the bidder or the applicant has made material misrepresentation or has given any materially incorrect or false information, appropriate legal/penal etc., action shall be taken by HLL Lifecare Limited including but not limited to forfeiture of EMD, Security Deposit, black listing etc., as deemed fit by HLL Lifecare Limited.
16. Conditional bids and bids not uploaded with appropriate/desired documents may be rejected outrightly and decision of HLL Lifecare Limited in this regard shall be final and binding.
17. HLL Lifecare Limited Ltd. reserves the right to verify the claims made by the bidders and to carry out the capability assessment of the bidders and the HLL Lifecare Limited's decision shall be final in this regard.

### **OTHER TERMS AND CONDITIONS**

1. Section 101 (Exemption of occupier or Manager from liability) of chapter X under the Factories Act 1948 (All LXIII of 1948) (23<sup>rd</sup> September 1948) is applicable
2. Payment will be released on monthly basis on submission of proper bills attaching the documents specified by the Company.
3. Taxes and duties are to be borne by the contractor only.
4. The contractor will have to submit an affidavit at the time of signing the agreement indicating that all employees of the contractor are paid the minimum wage as per Minimum Wages Act.
5. Preferably Contractor should have independent ESI and PF code number /**PAN number** and **GST** registration allotted by the concerned authorities (if required). The contractor will be solely and exclusively responsible to adhere to meet out all statutory obligations under Indian law in respect of compliance of all the rules, regulations and directions given by a statutory authority with regard to safety, labour laws, PF and ESI remittance or any other prevalent laws both of Central and State Enactments.
6. Contractor will comply with all the statutory norms including hours of work and Holidays / Rest etc.
7. The Contractor shall obtain and maintain a valid Contractor Licence from the Competent Authority under the applicable labour laws, including the Occupational Safety, Health and Working Conditions Code, 2020 and the rules made thereunder, or under the Contract Labour (Regulation and Abolition) Act, 1970, as applicable from time to time, before commencement of the work. The Contractor shall also obtain and maintain all other statutory registrations, licences, approvals, and permissions required for the execution of the contract and shall produce the same to HLL Lifecare Limited whenever called upon to do so.
8. Work is to be carried out strictly as per the schedule and any change in the mode of work if desired by HLL is to be implemented and the contractor shall supervise the work.
9. HLL Lifecare Ltd. has no obligation with regard to statutory and other welfare measures for the workmen employed by the contractor for the said contract.
10. In the event of unsatisfactory services rendered by the contractor, the contract may be cancelled by the HLL by giving one month's notice. In case the contractor is having any difficulty to continue the contract he /she should give a two-month notice in writing to HLL for short closing the

contract. In case the contract is short closed, HLL may forfeit the Security deposit / levy penalty as decided by the HLL authority.

11. No legal right shall vest in the contractor's workers to claim employment or otherwise absorption in neither HLL nor the contractor's workers shall have any right whatsoever to claim the benefit and/or emoluments that may be permissible or paid to the employees of HLL. The workers will remain the employees of the contractor and this should be the sole responsibility of the contractor to make it clear to his/her workers before deputing them to work at HLL.
12. The total HLL Campus is 'NO SMOKING ZONE'. Smoking, chewing tobacco / pan masala, consuming liquor etc. is strictly prohibited inside the premises. Violation of the same shall attract a penalty up to Rs.5000/- for each instance. Such penalty shall be recovered from the contractor's Bills.
13. HLL Lifecare Limited, Kanagala is ISO certified company under ISO 14001:2015 & ISO 45001:18001. It is therefore bidder to whom the work will be awarded has to follow and ensure the guidelines of ISO 14001:2015 and ISO 45001: 2018.
14. The contractor shall take applicable insurance or cover all the workmen under the provisions of ESI as the case may be.
15. On award of contract, Security Deposit (SD) of 3% of work order value in cash OR Bank guarantee of equivalent amount is to be submitted. OR SD will be recovered @3% from each bill. The SD amount will be returned without any interest by cheque only after satisfactory completion of the Contract. Bank Guarantee of Nationalized Bank only is acceptable.
16. The Bid Security deposited will not carry any interest.
17. In case of any damages caused to HLL property by contractor/his/her men while executing the job, the cost of the same shall be recovered from the contractor.
18. Confidentiality: Information relating to the examination, clarification, evaluation, and comparison of Bids and recommendations for the award of orders shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award has been announced in favour of the successful bidder.
19. The rates quoted should be valid till the completion of contract and will not be enhanced during the period of the contract on any account. Sub contract is not allowed.
20. Any effort by a Bidder to influence the Purchaser during processing of bids, evaluation, bid comparison or award decisions shall be treated as Corrupt & Fraudulent Practices and may result in the rejection of the Bidders' bid.

21. To assist in the examination, evaluation, and comparison of bids, the Tender Inviting Authority may ask the bidder for required clarification on the information submitted with the bid. The request for clarification and the response shall be in writing or by e-mail, but no change in the price or substance of the Bid shall be sought, offered, or permitted.
22. No Bidder shall contact the Tender Inviting Authority on any matter relating to the submitted bid from the time of the bid opening to the time the order is awarded. If the Bidder wishes to bring additional information to the notice of the Tender Inviting Authority, he shall do so in writing.
23. The Tender Inviting Authority reserves the right to negotiate with the lowest evaluated responsive bidder.
24. The rates quoted should be valid till the completion of contract and will not be enhanced during the period of the contract on any account. Sub contract is not allowed.
25. The Contractor has to ensure that all precautions are taken for safety of his employees and equipment.
26. Work is to be carried out strictly as per the schedule and any change in the mode of work if desired by us is to be implemented and the contractor shall supervise the work.
27. Contractor or his/her authorized representative shall solely entitled to instruct their workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
28. Workers engaged by contractors for aforesaid work shall be Contractors employee only and not of HLL Life Care Limited, Kanagala.
29. Transport / conveyance of workers engaged by the contractor is to be arranged by the contractor at his cost only wherever and whenever required or insisted.
30. Wage Slip indicating the PF deductions & employee individual PF number should be issued. Contractor shall disburse the wages to his employees deployed by him for the concerned contract work on or before 7<sup>th</sup> day of subsequent month following, irrespective of whether HLL Life care Limited has settled any of contractor's bills or not before that date.
31. Contractor shall disburse the payment to his deployed employees through e-payment mode i.e. through bank only. Non-compliance to this condition shall attract a penalty of Rs.5000.00 per month
32. Contractor to ensure that the employees deployed in the premises of HLL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification and experience etc. acceptable to concerned department.

33. The contractor shall arrange for the **Medical checkup** of his/her employees and produce the fitness certificate from the authorized hospital/Doctor before reporting for the work.
34. It is the contractors' responsibility for the safety aspects of his/her employees deployed for the work. He/she should provide necessary safety equipments like Shoes, Gloves, and Mask etc. at his/her own cost to his/her employees deployed for the said work wherever necessary. The safety and quality policy of the Company shall be complied by the contractor
35. The Company HLL Lifecare Ltd. reserves the right to cancel the contract at any time during the contract period without paying any compensation and the decision of the HLL Lifecare Ltd. with regard to termination of contractual provision will be final. In the event of contractor abandoning the work OR HLL revoking the contract HLL reserves the right to get incomplete work completed at contractor's RISK and COST. HLL shall have a right to terminate the contract at any time without assigning any reason thereof.
36. Contractor shall indemnify HLL against all claims by statutory authorities and losses under various labour laws, statutes OR any civil or criminal law in connection with the employees employed by him/her.
37. The contractor shall liable to pay statutory Bonus under payment of Bonus Act 1965 and submit proof of disbursement along with received copy of Form –D.
38. The contractor shall responsible for the discipline of his/her own laborers deployed under the service contract. In case of any loss to HLL on account of indiscipline of contract labour then such loss shall be assessed and recovered from the contractor's bills or from the security Deposit.

### **LEGAL COMPLIANCE**

1. The Contractor shall comply with all applicable provisions of the Occupational Safety, Health and Working Conditions Code, 2020, the Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020, and the rules, notifications, and amendments issued thereunder from time to time. The Contractor shall obtain and maintain all required statutory licences, registrations, records, and returns, and shall ensure timely payment of wages, bonus, EPF, ESI, and all other statutory dues applicable under law. Any penalty, interest, damages, or liability arising out of non-compliance with the applicable labour laws shall be the sole responsibility of the Contractor, who shall indemnify HLL Lifecare Limited against all such claims and liabilities.

2. The contractor shall make good all damage/loss which may be caused by any act or default of the contractor, his/her agents or servants or workers to any property of the Institute HLL reserves the option to make good the damage or loss by charging the contractor with the expenses.
3. Dispute if any, arising out of the contract shall be settled by mutual discussion or arbitration by sole arbitrator to be appointed by HLL at Hukkeri Court as per the provisions of the Indian Arbitration and Conciliation Act, 1996 and the rules framed there under. Any Arbitrator appointed shall not have the jurisdictions to pass any interim awards, or to grant interest higher than 8% charged simply on the award amounts or amounts payable to either party. No dispute arising of the execution, implementation or termination of the present contract, as also any other dispute with respect to the present contract be entertained by any court and shall be subject matter of Arbitration under the Indian Arbitration and Conciliation Act, 1996 and rules framed there under.
4. All legal disputes shall be subject to jurisdiction of Hukkeri court (Belagavi Dist. Karnataka) only.
5. The contractor shall submit duly signed undertaking enclosed with the tender document.
6. Unless otherwise stipulated in the Tender Notification, conditional offers, alternative offers, multiple bids by a bidder shall not be considered.
7. Bidder shall digitally sign all statements, documents, certificates uploaded by him, owning sole and complete responsibility for their correctness/ authenticity as per the provisions of the IT Act 2000 as amended from time to time.
8. Bidder must upload scanned copies of originals (or self-attested copies of originals – as specified). Uploaded PDF documents should not be password protected. Bidder should ensure the clarity/ legibility of the scanned documents uploaded by him.
9. Bids shall be received on or before the deadline for the bid submission as notified in Tender Notification.
10. The bidder shall not be able to submit his bid after the expiry of the deadline for the bid submission (as per server time). Therefore, a situation of Late Tender does not arise.

11. Notwithstanding anything in these Rules, Department of expenditure may, by order in writing, impose restrictions, including prior registration and/or screening on procurement from bidders from a country or countries, or a class of countries, on grounds of defense of India, or matters directly or indirectly related thereto including national security; no procurement shall be made in violation of such restrictions
