#### **Eligibility Criteria:**

- 1. The bidder should have experience for a period of 3 years or Institutional registered vendor or is a manufacturer/authorized dealer/sole distributor of any item. (Enclose copy of Certificate of Incorporation/Registration Certificate and Dealer/Distributer certificate of the firm.).

#### **QUALITY:**

The Product/Spare parts to be supplied must have minimum 6 Months of usable shelf life.

#### **DELIVERY:**

Free delivery at HLL. The supply may be made monthly, quarterly or biannually basis based on the proportionate quantity of requirement.

Delivery should be made within 3-5 days from the date of issue of Purchase order. Non-availability of the stock should be informed in writing immediately. Defective items or items not as per given specification, if any supplied must be taken back and be replaced with no additional cost. Packaging must be secure and appropriate to prevent damage during transit.

#### PENALTY:

Timely delivery is essence of the contract and hence if any consignment be delayed, liquidated damages at the rate 1% of the price of the delayed consignment, for each week or part whereof shall be levied and recovered subject to maximum of 5% of total purchase order value.

#### **LEGAL MATTER:**

In the event of any dispute over this contract, HLL's decision shall be final and binding.

#### **GENERAL TERMS & CONDITIONS:**

- The Purchaser reserves the right to Increase or decrease the quantity to be ordered up
  to 25 percent of bid quantity at the time of placement of contract. The purchaser also
  reserves the right to increase the ordered quantity by up to 25% of the contracted

  to accept the orders accordingly.
- 2. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The items are under CONTRACT for a period of ONE YEAR under scattered delivery. Further extension will be based on qualitative material and on timely supply of materials. The rates should not be escalated within the said contract period at any cost.
- 4.
