1. <u>COMPANY BACKGROUND</u>

HLL Lifecare Limited (HLL), is a Government of India "Mini Ratna" Public Sector Enterprise, under the Ministry of Health and Family Welfare, Government of India. Over the years, HLL has grown to serve many new areas in the field of healthcare in India in addition to manufacturing of contraceptives, and medical products.

HLL's purpose of business is "to be a globally respected organization focusing on inclusiveness by providing affordable and quality healthcare solutions through continuous innovations". In its quest to become a comprehensive healthcare solutions provider, HLL had diversified into hospital products and healthcare services, while nurturing its core business of providing quality contraceptives.

Healthcare Services Division

The Healthcare Service Division (HCS) of HLL is setting up and operating High-end path lab facilities and imaging centres across the country partnering with various State Governments and Central Government Institutions. The purpose of this division is to make available the high end path lab diagnostic facilities and imaging facilities to poor and needy patients at a much affordable rates. At present, HCS division of HLL has its presence in nine states.

Our first diagnostic facility in association with CGHS started functioning since February 2008 in New Delhi. Presently HLL operates 4 Medical Laboratories with High end equipment and installed four 1.5 Tesla MRI scanners in 5 Government Medical colleges in Kerala. The Healthcare Services Division (HCS) of HLL is planning to set up Diagnostic Services in various states across India. Already HLL is going to provide the services for NHM-Maharashtra in their free diagnostic initiatives.

Recently NHM-Assam also selected HLL as their service provider for the Chief-Minister's Free Medical Laboratory Diagnostic initiatives. For this particular project implementation, HLL is in the lookout for partners for patients sample Logistics from all these healthcare facilities (District Hospital; Community Health Center & Primary Health Center) to HLL's hub-labs located at various districts in the entire Assam state. HLL would like to expand the revenues of these labs by way of Business development in both public and private sector so as get optimum load of samples to have viable Lab Operations.

2. INTRODUCTION

As the service provider of Laboratory services to NHM-Assam, HLL has to set up 28 Labs across Assam. These Laboratory Centre (Hub) need to be set up in 28 locations for which the Govt will give space at the newly constructed diagnostic centres. HLL shall set up the facilities at their own cost. Depending on the terrain of Assam and the distances of these healthcare facilities with the Laboratory locations, in future, more labs may be required and NHM can direct HLL for the same.

For the convenience of payment to HLL, NHM-Assam has categorized the sample locations into three types namely District Hospitals (DH), Community Health Centres (CHC) and Primary Health centres (PHC). SDCH is Sub Divisional Civil Hospital and the payment of samples from these locations is same as that of CHC. There are different types of PHCs in Assam and for all; the payment structure is same as that of PHC.

At present the numbers of different service locations from where the sample collection is required is as given below:

3. <u>SCOPE OF SERVICES</u>

A. <u>Business Development</u>

The service provider shall ensure that

- The details of all the tests performed for the Health facility is informed to the consultant doctors of the Health Facility.
- All Samples are referred from all the listed Healthcare Facilities.
- All the referring physicians fill the Test Requisition Forms (TRF) properly
- Ensure that the total samples for the month from all the healthcare facilities (from 1207 Operational Healthcare facilities) are 182000 samples / month in all the Hub-Labs of Assam. On an average the sample load per operational healthcare facility would be approximately 150 nos (1,82,000 /1207) samples/ month.

The penalty for non-achivement of the Target is mentioned below:

For Example: If only 600 healthcare facilities are operational under HLL, then the service provider is expected to generate a sample load of (600x150) 90000 samples per month. The above deductions would be applicable on a target of 90000.

B. <u>Stocking & Transportation of Reagents & Consumables</u>

- The reagent & consumables list will be given to the bidder
- They have to stock all these items in adequate quantities in the warehouse.
- They need to deliver the items within 48 hours of indent reaching them

5. <u>SELECTION PROCESS</u>

The strategic partner shall be selected through a competitive bidding process.

The bidding process shall be carried out in two stages:

Technical Evaluation

(i) The Technical Evaluation Committee (TEC) of HLL will screen the Tender based on the Minimum Eligibility Criteria. The firms that fulfill Minimum Eligibility Criteria will only be technically shortlisted.

Financial Evaluation

- (ii) Financial bids of the company passing the technical evaluation only will be opened. The financial bids of the bidders failing to qualify the technical evaluation will be returned unopened.
- **6.** <u>VALIDITY OF CONTRACT</u>: Five (5) Years from the date of signing of the contract or the Date of Expiry of Agreement of HLL with the Principals, whichever is earlier.

7. EARNEST MONEY DEPOSIT (EMD)

- The Bid shall be accompanied with an Earnest Money Deposit (EMD) of Rs 2,00,000.00 (Rupees two Lakhs Only) in the form of a Demand Draft drawn in favour of "HLL LIFECARE LIMITED, THIRUVANANTHAPURAM" issued by any Nationalized/Scheduled banks payable at Thiruvananthapuram. Payment in any other form will not be accepted.
- Bid submitted without EMD shall be summarily rejected.
- No interest shall be paid on any of these deposits.
- Separate EMD shall be furnished for each Region.
- It may be noted that no tendering entity is exempt from deposit of EMD.
- The EMD of unsuccessful bidders will be returned to them within one month of conclusion of contract with the selection of successful bidder.
- The EMD of the successful bidder will be returned without any interest, after receipt of performance security as per the terms of contract.
- EMD of a bidder will be forfeited without prejudice to other rights of the purchaser, if the bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender or if it comes to notice that the information /documents furnished in its tender is incorrect, false, misleading or forged. In addition to the aforesaid grounds, the successful bidders' EMD will also be forfeited without prejudice to other rights of purchaser, if it fails to furnish the required performance security within the specified period.

8. <u>PREPARATION & SUBMISSION OF BIDS</u>

The bidders shall submit the hardcopy of the Tender within the stipulated time. Documents in electronic form will not be accepted. The Tender shall be made in TWO SEPARATE SEALED ENVELOPES as follows for each Region:

- b. Pay compensation as claimed by HLL in the event of the strategic partner failing to provide services for the stipulated period.

(2) Financial Bid:

Financial Bid Submission

- The strategic Partner can quote the % of revenue share requirement for each sample.
- Bidders have to quote their % of revenue share up to two decimal.
- Bidders have to seperatley quote the % of share of revenue for the Business Development activity for which they are entrusted.
- Bidders can separately quote the % of revenue share for stocking and transporting the reagents & consumables
- Bidders have to mention the total % of revenue share.
- To be submitted by the bidders in their letter head
- The bidder who is bidding the lowest percentage revenue share (Total %) shall be selected as the Business Associate of HLL for the NHM project in Assam.

Evaluation of Bid

Scrutiny of Bids: The Bids will be scrutinized to determine whether they are complete and meet the essential and important requirements, conditions and whether the bidder is eligible and qualified as per criteria laid down in the Bid Enquiry Documents. The bids, which do not meet the aforesaid requirements, are liable to be treated as non-responsive and may be ignored. The decision of the purchaser as to whether the Bidder is eligible and qualified or not and whether the bid is responsive or not shall be final and binding on the bidders. Financial bids of only those bidders, who qualify technical bid, will be considered.

Infirmity / Non-Conformity: The purchaser may waive minor infirmity and/or non-conformity in a Bid, provided it does not constitute any material deviation. The decision of the purchaser as to whether the deviation is material or not, shall be final and binding on the bidders.

Bid Clarification: Wherever necessary, the purchaser may, at its discretion, seek clarification from the Bidders seeking response by a specified date. If no response is received by this date, the purchaser shall evaluate the offer as per available information.

- > Opening of Technical Bids will be done initially.
- The financial bid of technically qualified bidders only will be opened and the schedule for the same will be informed to the technically qualified bidders well in advance.
- > Financial Bids of technically unqualified bidders will be returned un-opened.
- The bid shall remain valid for a period of one year from the date of opening of the financial bids.
- > The financial bid shall be evaluated based on the lowest percentage of revenue share.
- HLL may reject all proposals if they are found to be unresponsive or unsuitable if they represent major deficiencies in complying with the requirements.
- The selected strategic partner shall commence the services within two weeks of issue of LOI by HLL.

HLL reserves the right to give either any of the component of the scope or adding multiple scopes.

HLL will award the contract to the L1 bidder and the bidder who receives the award of work has to execute an agreement with HLL detailing the scope of work, Obligations of HLL & the successful bidder, Termination Clause etc.

ETHICAL STANDARD:

Bidders are expected to observe the highest standard of ethics during the execution of this Contract. In pursuit of this policy, HLL will reject a proposal for award if it determines that the Bidder being considered for award has engaged in corrupt or fraudulent practices in competing for the Contract. For the purposes of this provision, the terms set forth below are defined as follows:

Corrupt practice: means the offering, giving, receiving, or soliciting of anything of value to influence the action in the process or in Contract execution; and

Fraudulent practice: means a misrepresentation of facts in order to influence procurement process including collusive practices designed to establish bid prices at artificial, non-competitive levels to deprive HLL of the benefits of competition.

COST OF BIDDING:

The Bidder shall bear all costs associated with the preparation and submission of its bid, and HLL shall in no case be responsible or liable for those costs.

Documents in electronic form will not be accepted.

B. <u>Performance Security</u>

- The successful bidder shall submit performance security for a total value of Rs 10, 00,000.00 (Rupees Ten Lakhs Only) in the form of Bank Guarantee issued by a scheduled/nationalized bank in favour of HLL Lifecare Ltd for each Region.
- The BG format shall be issued to the successful bidder by HLL along with Lol/WO and the successful bidder shall provide the BG strictly in such format.
- The Performance Security shall be submitted within 15 days (minimum) of receiving of LoI / work order, failing which the EMD may be forfeited and the contract may be cancelled.
- The Performance security shall be liable for forfeiture, wholly or partly, in case of Violation of any of the terms and conditions of the contract and / or deficiency in service as agreed especially if the strategic partner consistently failed in maintaining the TAT or Fail in ensuring quality of the tests in one quarter.

C. Bid Validity

The bids shall remain valid for acceptance for 180 days from the date of opening of Bids and the contract will be valid for duration of 5 years or for a period upto the Date of Expiry of Agreement of HLL with the Principals, whichever is earlier.

D. <u>Delivery Period</u>

The successful bidder shall commence the proposed services within two weeks from the date of issue of LOI/WO by HLL Lifecare Ltd. The successful bidder shall execute a detailed contract/agreement with HLL in the format proposed by HLL within 15 days from the date of issue of HLL's LoI/ work order along with submission of Performance Security.

E. Award of Contract:

Successful bidder must sign the agreement with HLL within 15 days from the date of Notification of Award along with submission of Performance Security.

Contract will be initially valid for a period of 60 months from the date of Notification of Award and the same may be extended after reviewing the performance.

F. Payment Terms

- a) After completing one month services the bidder has to submit the invoices to HLL.
- b) Invoices with correct rates with of sales through Business development, Reagents & Consumables delivered etc as per tender should be provided on a monthly basis.
- c) Payment will be made within 90 days from the receipt of correct bills.
- d) Payments shall be released after making the income tax deduction at source (TDS) at the applicable rates.

G. Liquidated Damages

• If the successful bidder fails to execute the contract with in the stipulated time, there shall be levied liquidated damages equal to 0.5% of the contract value for each week of delay till the delay continues, up to a maximum limit of 5% of the contract.

H. Taxes and Duties

The Bidder shall bear and pay GST assessed on the bidder by all state, or national government authorities, in connection with the Services provided under the Contract. Income Tax and Other Taxes as applicable at the time of execution of job or any other government-imposed liabilities would be deducted from each bill submitted by the bidder.

I. Confidentiality:

This contract, its provisions and existence as well as any commercial data including price or technical data and any information provided in accordance herewith to the other party shall be considered as confidential. Such information shall not be disclosed to any third party unless required by any applicable law or authorized in writing by the other party. All such information shall be used by the other party only for the performance of this contract.

The restrictions here-in-above shall not apply to any information generally available to public or received in good faith from a third party without restriction. The parties hereby agree to keep as confidential all documentation furnished or received by either party at any time in connection with this contract. This provision as far as practicable shall apply to all the concerned officers of either party. This clause shall survive upon termination of this contract.

In case of any loss or damage sustained to HLL due to the breach of confidentiality clause of this agreement, the bidder is liable to compensate HLL to the extent of actual loss suffered by HLL.

J. Other Conditions

The service provider shall not have the right to assign to any party except its subsidiaries/ associates/ joint ventures its rights and obligations arising out of this contract in connection with it without the prior written consent of HLL.

HLL reserves its right either to select or reject any offer without assigning any reasons.

The Bidder has to give a declaration that they have not been blacklisted by any Government organization, as per Annexure IV.

K. Arbitration

- a) If a dispute or difference of any kind between HLL Lifecare Ltd and the strategic partner in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual discussions.
- b) If the parties fail to resolve the dispute or difference by such mutual consultations within 21 days of commencement of consultations, then either HLL Lifecare Ltd or strategic partner may give notice to the other party of its intention to commence arbitration, as hereinafter provided.
- c) The applicable arbitration procedure will be as per the arbitration and conciliation Act, 1996 of India. In the event of Arbitration, the dispute or difference shall be referred to the sole arbitration of an officer to be appointed by HLL Lifecare Limited venue of Arbitration shall be Thiruvananthapuram.

L. Force Majeure:

Force Majeure shall mean any event beyond the reasonable control of HLL or of the Bidder, as the case may be, and which is unavoidable notwithstanding the reasonable care of the party affected and shall include, without limitation, the following:-

- (a) War, hostilities, or warlike operations (whether a state of war be declared or not), invasion, act of foreign enemy, and civil war;
- (b) Rebellion, revolution, insurrection, mutiny, usurpation of civil or military government, conspiracy, riot, civil commotion, and terrorist acts;
- (c) Strike, sabotage, lockout, embargo, import restriction, industrial dispute, epidemics, quarantine, and plague;
- (d) Earthquake, landslide, volcanic activity, fire, flood or inundation, tidal wave, typhoon or cyclone, hurricane, storm, lightning, or other inclement weather condition, nuclear and pressure waves, or other natural or physical disaster immediately effecting project implementation;

If either party is prevented, hindered, or delayed from or in performing any of its obligations under the Contract by an event of Force Majeure, then it shall notify the other

in writing of the occurrence of such event and the circumstances of the event of Force Majeure within seven (7) days after the occurrence of such event.

M. Termination of Contract

HLL Lifecare Ltd may terminate the contract, if the successful tenderer/bidder withdraws its tender/bid after its acceptance or fails to submit the required performance security or fails to fulfil any other contractual obligations.

In that event HLL Lifecare Ltd shall have the right to avail the required services from the next eligible bidder and the extra expenditure on this account shall be recoverable from the defaulter.

However, HLL may, at its convenience, terminate the contract for convenience in the interest of HLL by giving three months written notice.

However, HLL or the Selected vendor may short-close the contract with a notice of 3 months without assigning any concrete reason.
