#### 1. Product requirement with Quantity

#### 2. Details of Tender

The major details of present tender are the following:

- 1. The above product requirement are on a urgent basis
- 2. The offered product(s) must 100% comply with the specification mentioned below for each product being quoted.
- 3. Bidders need to submit a compliance certificate from the principal manufacturer that the specification of the offered product is 100% complying with the specification mentioned in the tender **Annexure -3**
- 4. Bidder should submit relevant brochure and technical data sheet and certificates for the offered product(s).
- 5. Bidder should submit copy of valid Certificate of the following and provide other details as per the **Annexure-2**:
  - a. GST Registration
  - b. IT PAN Card
- 6. All items being quoted need to be delivered anywhere in India mainly Chennai, Bangalore, Mumbai, New Delhi, and Ahmedabad. The consignee address to which delivery has to be done will be mentioned in the Purchase order

#### 3. Price Details

The Price details must be prepared in accordance with the instructions specified below:

- a) The Price must be quoted in accordance with **Annexure-1** attached.
- b) The Price total must include all costs associated with the execution of the contract including taxes, levies, duties, GST, freight, insurance etc and on **Door Delivery basis anywhere in India mainly Chennai, Bangalore, Mumbai, New Delhi, and Ahmedabad**

#### 4. Bid Currencies

Prices shall be quoted in Indian Rupees.

#### 5. PAYMENT TERMS

- 5.1 The payments shall be released to the supplier within 5 days from the date of receipt and acceptance of the material at consignee address.
- 5.2 The amount shall be paid by HLL in Indian Rupees.





#### 6. Delivery Terms

Goods shall be delivered strictly as per the delivery schedule indicated from the date of Purchase order by HLL.

#### 7. Taxes and Duties

The Bidder shall bear and pay all taxes, duties, levies, GST and charges assessed on the bidder by all municipal, state, or national government authorities, loading & unloading charges etc in connection with the Goods and Services supplied under the Contract. Income Tax and Other Taxes as applicable at the time of execution of job or any other government-imposed liabilities would be deducted from each bill submitted by the bidder

### 8. HLL's Right to Accept or reject any or all Bids

HLL reserves the right to accept or reject any bid or to annul the bidding process and reject all bids at any time prior to placement of purchase order, without assigning any reason thereof. The purchaser does not bind itself to accept the lowest or any bid and reserves the right to reject any or all bids at any point of time prior to the issuance of the Purchase order without reason whatsoever.

Canvassing of any kind will be a disqualification and the purchaser may decide to cancel the bidder from its empanelment.

#### 9. PURCHASER'S RIGHT TO VARY QUANTITIES AT TIME OF AWARD

The Purchaser reserves the right at the time of award of contract to increase or decrease the quantity of goods and services originally specified in the bid document without any change in unit price or other terms and conditions

#### 10. Recall

The products/goods must be recalled by the manufacturer/ bidder/ supplier at the manufacturers/ bidder/ suppliers cost if rejected by HLL/ purchaser or end user because of the problems with product quality. The supplier/ bidder/ manufacturer will be obliged to replace the product in question at its own cost with a new machine of acceptable quality.

#### 11. Settlement of Disputes

Arbitration shall not be a means of settlement of any dispute or claim arising out of the contract relating to the work. Any disputes or difference arising between the parties with respect to the performance of any part of this agreement or anything connected therewith, etc shall as far as possible be mutually settled by the process of dialog and negotiation. Any disputes or differences or questions or claims arising under or relating to a concerning or touching this agreement shall be referred for arbitration in accordance with the provisions of the Arbitration and Conciliation Act 1996.

The arbitration proceedings shall be held at Thiruvananthapuram. The award passed by the arbitrator shall be final and binding on the parties hereto. The conduct of such arbitration shall be in English. Subject to arbitration, the Courts at Thiruvananthapuram alone shall have jurisdiction in respect of settlement of any matter arising out or in connection with the contract.

#### 12. Major Responsibilities of Supplier

a. The suppliers have to supply the goods as per the delivery schedules and quantity mentioned in the Purchase order. Supplies made shall be in strict conformance with





the stipulations of the specification mentioned below and the respective Purchase orders.

- b. The Supplier shall comply with all laws in force in India. The laws will include all national, provincial, municipal, or other laws that affect the performance of the Contract and are binding upon the bidder. The Bidders shall indemnify and hold harmless HLL from and against any and all liabilities, damages, claims, fines, penalties, and expenses of whatever nature arising or resulting from the violation of such laws by the bidder or its personnel except that caused by HLL.
- c. Any product related legal issues shall be handled and connected expenses therewith shall be borne by the supplier only.
- d. Any product related cases shall be handled and connected expenses therewith shall be borne by the supplier only
- e. The final quantities mentioned above may vary as per the final requirement and the order may be placed in single or multiple lots during the bid validity period.

#### 13. Termination

HLL reserve right to terminate/ cancel the Purchase order at any time for any reason without any liability on HLL.

#### 14. PACKING

- 16.1 The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods final destination and the absence of heavy handling facilities at all points in transit. Packing shall adhere to conditions stipulated in Technical specification.
- 16.2The packing, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be provided for in the Purchase Order

# 1. Goggles

- With transparent glasses, Zero power, well fitting, covered from all sides with elastic band/or adjustable holder.
- Good seal with the skin of the face.
- Flexible frame to easily fit all face contours without too much pressure.
- Covers the eyes and surrounding areas and accommodates for prescription glasses.
- Fog and scratch resistant.
- Adjustable band to secure firmly so as not to become loose during clinical activity.
- Indirect venting to reduce fogging.
- May be re-usable (provided appropriate arrangements for decontamination are in place) or disposable.
- Quality compliant with the below standards, or equivalent:
  - a. EU standard directive 86/686/EEC, EN 166/2002
  - b. ANSI/SEA Z87.1-2010

# 2. N-95 Masks (With / Without valve)

- Shape that will not collapse easily
- High filtration efficiency
- Good breathability, with expiratory valve
- Quality compliant with standards for surgical N95 respirator:
  - a. NIOSH N95, EN 149 FFP2, or equivalent
- Fluid resistance: minimum 80 mmhg pressure based on ASTM F1862, ISO 22609, or equivalent.
- Quality Compliant with standards for particulate respirator that can be worn with fullface shield

### 6. Gloves in pairs of Size 6.5 & 7.0 each

- Nitrile
- Non-sterile
- Powder free
- Outer gloves preferably reach mid-forearm (minimum 280mm total length)
- Different sizes in pairs of 6.5 & 7.0 each
- Quality compliant with the below standards, or equivalent:
  - a. EU standard directive 93/42/EEC Class I, EN 455
  - b. EU standard directive 89/686/EEC category III, EN 374
  - c. ANSI/SEA 105-2011
  - d. ASTM D6319-10
- Packing The Product should be supplied in boxes of 100 pieces (The gloves of size 6.5 & 7.0 shall be individually packed.

All items to be supplied need to be accompanied with certificate of analysis from national/international organizations/labs indicating conformity to standards.
