TERMS AND CONDITIONS

- The vehicles should be roadworthy, in good condition, and should have valid registration, road permit, records of having paid road tax and insurance, to carry out Transportation of Goods and materials as mentioned. The vehicle should be provided with a covered body. It is the responsibility of the contractor to ensure all legal requirements of the vehicle like valid registration, pollution certificate, fitness certificate, tax payment or any other relevant documents etc and HLL won't be liable for any lapses in this regard.
- 2. The vehicle offered should have valid fitness certificate issued by RTO and the bidder should submit copy of RC Book, Road Tax and Insurance paid Certificate, Fitness Certificate, Goods carriage permit and Pollution Certificate duly self-attested along with Tender document.
- 3. The Contractor should ensure that the goods and materials transported is protected from dust, rain, pilferage, etc by proper covering till the materials are unloaded at the locations specified from time to time. In case of any loss or damage to the goods in transit, the cost of the material along will be recovered from the contractor, from the amount payable to him/her or from security deposit made by him/her to the Company.
- 4. In case of any accident or loss or damage that happens either to the vehicle or to the driver or any persons within or not within the company, shall be taken care of by the contractor. The contractor alone will be liable for compensation if any to be paid and the company shall not have any liability in this regard.
- 5. The Contractor should have GST Registration (if applicable) and shall produce a copy of the Registration Certificate to the Company before commencement of the Work.
- 6. Collecting the Boxes/Materials from the pickup location (inside plant area, warehouses or any other location etc.), safely loading in the vehicle, safely unloading and arrange batch wise at the delivery location as per the instruction from the concerned HLL officer would be in the scope of the awarding party without any extra payment. Man power arrangement for the works to be in the scope of awarding party without any extra payment.
- 7. The breakup of the rate should be furnished in the price bid. Income tax as applicable will be deducted. (HLL Lifecare Limited, Kakkanad Factory, Kochi is situated in Cochin Special Economic Zone, hence GST is Zero rated for us.)

- 8. The Contractor shall submit bills for payment on monthly basis and the bills will be paid within 30 days of receipt of the bills.
- 9. Tender forms duly completed should be submitted along with EMD by way of DD favoring HLL Lifecare Limited, Kakkanad Factory, Ernakulam as detailed below:
- 10. Tender received without EMD & Tender Fee shall be rejected. (Those bidders exempted from EMD shall submit copy of Udyog Aadhar/MSME Certificate)
- 11. Forfeiture of EMD: The EMD will be forfeited if the Bidder withdraws the bid after opening of the tender or fails to sign the Contract/Agreement or fails in providing the vehicle during the currency of the period of agreement.
- 12. The Drivers engaged by the contractor should be experienced and should have valid driving license. They should have good character and conduct. In case the Company desires to change the driver, the contractor should provide substitute immediately. Necessary Insurance coverage should be taken by the contractor for the drivers and cleaners engaged by him. To ensure the validity of driving license of the driver would be the responsibility of the contractor and HLL won't be liable regarding the license validity of the driver.
- 13. There shall be no employer employee relation between the HLL and the driver and cleaner. The whole supervision and control of driver and cleaner shall be with the contractor. They shall be employees of the owner of the vehicle (Contractor).
- 14. In case of failure to place vehicle on any working day, HLL shall arrange another vehicle and the expense incurred will be deducted from the transporter. If any such cases repeated frequently, HLL has the right to cancel the contract. In case of any urgency, HLL shall inform the contractor to arrange the shifting on holidays and out of normal office hours. In those situations, also, the contractor should arrange the material shifting with the same price.
- 15. The company retains the right to have a panel of transporters and allocate loads to the transporter in the panel as per requirement.
- 16. HLL reserves the right to examine and accept / reject any documents after the tender opening without assigning any reason.
- 17. Security deposit for this tender will be 3 % of the work order value subject to maximum of Rs.20,000/-. The EMD of the successful bidder will be adjusted against Security Deposit and the bidders are required to remit the balance amount. The successful bidder/'s are required to furnish the Security Deposit within 15 days of award of work.


