The terms and conditions of the bid are given below.

- 1. The prices should be quoted as per the format for price schedule enclosed as **Annexure –II.**
- 2. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser.
- 3. The prices quoted shall be valid for a period of 90 (Ninety) days from the date of opening of bids.
- 4. The items should be delivered and installed within 2 (Two) weeks from the date of issue of Purchase Order.
- 5. Penalty @ 0.50 % of the total Purchase Order value for each week of delay or part thereof subject to a maximum of 5 % is applicable for the delay in completion of the works.
- 6. The bid shall be evaluated by taking the total amount quoted for all the items.
- 7. Bids should be clear in all respects and those with ambiguous and conditional clauses shall be rejected.
- 8. The bidder who requires any clarification on the tender shall notify the undersigned through e-Mail at **sivakumar@lifecarehll.com**. However no post bid clarification shall be entertained.
- 9. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.
- 10. HLL will have the right to increase or decrease up to 20% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions during the validity period.
- 11. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.

- 12. The supply order shall be placed on the lowest responsive bidder.
- 13. Payment will be released within 30 days from HLL Lifecare Ltd, Corporate and registered Office, Poojappura, Trivandrum against successful delivery and acceptance by HLL. For claiming the payment, the following documents are to be submitted.
