## TERMS AND CONDITIONS FOR HIRING OF VEHICLES FOR OFFICIAL USE ON CONTRACT BASIS

- 1) The tenderer must be the owner of vehicles. The vehicle should be registered after January 2012. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.
- 2) The bidder should not offer vehicles which are already under contract with other units of HLL or with any other organization.
- 3) An EMD of Rs.5,000/- (Rupees five thousand only) per vehicle by way of Demand Draft favouring HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.
- 4) The rate should be quoted in the enclosed format.
- 5) An amount of Rs.10,000/- is to be remitted as security deposit by the successful tenderer, for each vehicle.

- 12) No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill after statutory deductions such as Income Tax. The contractor should also ensure that minimum wages is paid to the driver and a certificate to this effect shall be submitted by the contractor along with the monthly bill.
- 13) The charges for additional Kilometers, if any, will be paid every month at the rates finalized.
- 14) If the services of the contractor are not satisfactory, HLL Lifecare Limited reserves the right to cancel the contract after giving 30 days notice.

- 20) The contract will be for a period of three years. The contractor shall provide the vehicles based on the requirement of the company.
