The server and its maintenance is responsibility of the bidder and maintenance cost of the server (if any) should be quoted separately on yearly basis (after warranty period) and this cost shall be loaded for 3 years (say) for evaluation and ranking purpose

#### 4. Existing:

Para. 2b: The Tenderers quoting as authorized representative of the manufacturer **meeting the above criteria 2 (a) should have executed at least one contract** in the last five years from the date of tender opening of similar equipment meeting major parameters of technical specification which is functioning satisfactorily, anywhere in India of the same manufacturer

#### Read as

The Tenderers quoting as authorized representative of the manufacturer **meeting the above criteria 2 (a) should have executed at least one contract** in the last five years from the date of tender opening of similar equipment meeting major parameters of technical specification which is functioning satisfactorily, **anywhere in India of any manufacturer. Proof of acceptance and/or satisfactory installations issued by consignee/purchaser shall be accepted for this qualification criterion.** 

All other contents of the tender enquiry including terms & conditions remain unaltered.
