- 3. Payment will be released on monthly basis on submission of proper bills attaching the documents specified by the Company.

- 24. Contractor shall disburse the payment to his deployed employees through e-payment mode i.e. through bank only. Non-compliance to this condition shall attract a penalty of Rs.5000.00 per month
- 25. Contractor to ensure that the employees deployed in the premises of HLL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification and experience etc. acceptable to concerned department.
- 26. The contractor shall arrange for the Medical checkup of his/her employees and produce the fitness certificate from the authorized hospital/Doctor before reporting for the work.
- 27. It is the contractors' responsibility for the safety aspects of his/her employees deployed for the work. He/she should provide necessary safety equipments like Shoes, Gloves, and Mask etc. at his/her own cost to his/her employees deployed for the said work wherever necessary. incomplete work completed at contractor's RISK and COST. HLL shall have a right to terminate the contract at any time without assigning any reason thereof.

- 29. Contractor shall indemnify HLL against all claims by statutory authorities and losses under various labour laws, statutes OR any civil or criminal law in connection with the employees employed by him/her.
- 30. The contractor shall liable to pay statutory Bonus under payment of Bonus Act 1965 and submit proof of disbursement along with received copy of Form –D.
- 31. The contractor shall responsible for the discipline of his/her own laborers deployed under the service contract. In case of any loss to HLL on account of indiscipline of contract labour then such loss shall be assessed and recovered from the contractor's bills or from the security Deposit.
- 32. The contractor shall not employ any person who has not completed his/her 18 years of age and person who attained 60 year of age.

33. LEGAL COMPLIANCE

The Contractor shall comply with all the provisions regarding licensing, welfare & health procedures, maintenance of various records & registers etc. as provided under the Contract Labour (Regulation & Abolition) Act 1970, rules amendments, orders, notifications there under issued by the Appropriate Govt. from time to time. For non-compliance of any provisions, statutory compliances under law, the contractor shall be responsible for penalties levied by the appropriate authorities under the Act. The contractor shall also be liable to comply with all other labour & Industrial Laws and such other Act, payment of Bonus Act, Minimum Wages Act etc. Depositing ESI, PF Contributions as may be applicable is the responsibility of the contractor for any default in compliance the contractor shall be held responsible.

- 34. The contractor shall make good all damage/loss which may be caused by any act or default of the contractor, his/her agents or servants or workers to any property of the Institute HLL reserves the option to make good the damage or loss by charging the contractor with the expenses.
- 35. Dispute if any, arising out of the contract shall be settled by mutual discussion or arbitration by sole arbitrator to be appointed by HLL at Hukkeri Court as per the provisions of the Indian Arbitration and Conciliation Act, 1996 and the rules framed there under. Any Arbitrator appointed shall not have the jurisdictions to pass any interim awards, or to



grant interest higher than 8% charged simply on the award amounts or amounts payable to either party. No dispute arising of the execution, implementation or termination of the present contract, as also any other dispute with respect to the present contract be entertained by any court and shall be subject matter of Arbitration under the Indian Arbitration and Conciliation Act, 1996 and rules framed there under.

- 36. All legal disputes shall be subject to jurisdiction of Hukkeri court (Belagavi Dist. Karnataka) only
- 37. In case of back out from the commitment, the SD will be forfeited/Penalty followed by blacklisting.
- 38. The contractor shall submit duly signed undertaking enclosed with the tender document.

Specific Terms and condition for the operation of CETP

- 1) CETP is operated in three shifts. One-man power in each shift is required for the Operation of CETP, however management reserves the right to increase or decrease the manpower on need basis.
- 2) No shift will be kept blank at any time and operator has to leave the work spot after his reliever takes the charge.
- 3) Minimum qualification of operator required is preferably PUC or SSLC passed.
- 4) Contractor should supply Cow dung required for the process. Approximately 100 kg per quarter.
- 5) Contractor has to provide Safety shoes separately for the each operator.
- 6) Operator should have the knowledge of operating CETP.
- 7) In case of any damage caused to our (HLL) property by contractor/ his labor while executing the above work the company (HLL) shall recover the cost of damage from the contractor.
- 8) In the event of any accident to the labor / personnel while executing the work in the Company premises contractor shall be responsible for the same and shall pay the Compensation as per the WCA and the rates framed there under.
- 9) Required personal protective such as hand gloves, gumboots if necessary should be provided while cleaning the tanks, Sand & Carbon filters and culture preparation and Mechanical nature work.
- 10) The Contractor shall arrange to give the samples to laboratory on monthly and as when required basis. It is contractor responsibility to maintain output water Parameters within the norms.
- 11) It is the responsibility of the contractor to see that good housekeeping is maintained in and around the CETP plant with full greenery. The treated water daily shall be used and Plantation shall be maintained.
- 12) Contractor has to ensure of running the CETP plant for 16 hours every day.
- 13) Training for period of one week on running of the unit will be imparted, for which no claim shall be made. However contract has to provide the list of employees before deployment and get it approved by us. Subsequent training to the new employees deployed, if any, shall be the responsibility of the contractor only and no additional payment will be made.
- 14) Tanks cleanings shall be done as per annexure E.

- 2. Plant shall not be kept idle for more than 60 minutes, in view of danger to life of bacteria.
- 3. Training for period of one week on running of the unit will be imparted, for which no claim shall be made. However contract has to provide the list of employees before deployment and get it approved by us. Subsequent training to the new employees deployed, if any, shall be the responsibility of the contractor only and no additional payment will be made.
- 4. Contractor has to arrange to collect samples of effluent & check the PH value of it by ph meter/Litmus paper. Prepare additives like 10% solution of Caustic soda, Ferric Alum & HCL & add the same to holding / neutralizing tanks.
- 5. Contractor should ensure to maintain levels of effluent steam & domestic sewage at proportioning tank as per SOP. (Standard operating procedure).
- 6. Contractor is responsible to remove the dried sludge from the primary & secondary Sludge tanks & collect in bags & dispose it off at designated area.
- Contractor should arrange to maintain shift basis logbook stock levels of chemicals used at ETP, quantities available & used in each shift, & report to OCP shift officer and Safety/ ENV officer take the signature. (Mandatory)
- 8. Contractor has to arrange to operate the ETP as per SOP & SCP & follow the instruction given by the officer concerned on time-to-time basis.

- 15. Maintenance of Softener plant such as putting salt, back wash, and other activities should be carried out as per compounding officer instruction.

1. CONDOM ETP

- a) Inspection of all tanks at beginning of shift. Checking and noting of water flow meter, energy meter and consumption details and entering in log book.
- b) Preparation of Alum solution.
- c) Operation of garden discharge pumps and other water lift pumps.
- d) Accumulated algae removing from Hot water storage tank.
- e) Acid pouring in Latex liquid storage tank, for coagulation.
- f) Coagulated latex removing from three tanks and filling into plastic bags and handing over to Store along with housekeeping person.
- g) Helping to electrical and mechanical department for engineering nature ETP maintenance.
- h) Maintaining of rain harvesting well as per instruction of Mechanical department.
- i) Maintaining of hazardous waste received from OCP, BDU and Unipill Plant.
- j) ETP running with Alum dozing weekly thrice, each time minimum four hours.
- k) Hot water pipeline cleaning weekly once.
- I) Drain of Alum weekly once from Alum tank.

2. FILTER PRESS

- a) Filter press running continuously all the three shift.
- b) Filter cloth cleaning daily 1st and 2nd shift. Two hours in each shift.
- c) Collected solid silica waste from Filter press in trolley is dumping in solar pond manually by using spade. Time required in each shift 35, minutes.
- d) Acid solution preparation in barrel for dozing at outlet water of Filter press to reduce pH.



- e) Filter press cloth changing with spare, twice in a month.
- f) Filter cloths removed are cleaning with bleaching powder.

3. Softener Plant:

- a) Regeneration weekly thrice. Each time three hours.
- b) Helping housekeeping person to put salt in Sintex tank weekly thrice. Each time 900Kgs. Salt carrying from storage room to Softener Plant.

4. R.O.Plant
