Terms & Conditions

- 1. The respective bidder should have minimum 3 years experience in UTM Implementation/Support. For this, the bidder can submit the documentary evidence of the following along with the bid.
 - a. The copies of Supply / work orders for the similar kind of items for the past three years.
 - b. Certificate from at least three clients for the similar works done
- 2. The prices should be quoted as per the format for price schedule enclosed as **Annexure 1.**
- 3. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser.
- 4. The bids will be evaluated by taking the total amount for all the items.
- 5. The supplier has to supply the product with license at Head office and necessary support should be provided at the place where UTM is kept.
- 6. The Authorization Letter from the OEM of the product quoted should be submitted along with the bid.
- 7. The prices quoted shall be valid for a period of 30 days from the date of opening of bids.
- 8. The support should be provided within **2 weeks** from the date of placement of order.
- 9. Penalty at 0.5% per week's delay subject to maximum of 5% is applicable for delayed delivery.
- 10. Necessary documentations/CDs/DVDs are to be supplied along with the product.
- 11. Statutory documents like licenses if any should be supplied along with the product.

- 12. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 13. The supply order will be placed on the first lowest responsive bidder.
- 14. The periodic updates from OEM should be available at free of cost during the support period.
- 15. Necessary support should be provided as and when required within 2 Hrs of intimation of problem.
- 16. HLL will have the right to increase or decrease up to 20% of the quantity of licenses specified in the schedule of requirements without any change in the unit price or other terms and conditions.
- 17. Payment will be released within 30 days from the date of delivery and installation of the items.
