The bids should be signed by Authorised Person from the bidder's organization along with Authorization letter.

3. Financial BID:-

The financial BID should consist of financial offer as per Annex-2

Rates quoted should be **all inclusive** including taxes, maintenance and genuine spare parts cost. The rates should be inclusive of Taxes & Duties as applicable.

Important Terms & Conditions:

- 1. The CAMC is for a period of 03 (Three) Years from the date of Award of Contract, duly extendable every year on satisfactory performance for 2nd & 3rd year.
- 2. The Comprehensive Annual Maintenance Contract (CAMC) shall be operative immediately after award of the contract. HITES NOIDA reserve the right to reject any quotation in whole or in part without assigning any reason thereof.
- 3. The selected firm will raise the bills on Quarterly basis and the payment shall be released in four quarterly installments.
- 4. The rates quoted shall remain in force for the full period of contract. No demand for revision of rates on any account whatsoever shall be entertained during the period of the contract.
- 5. During the validity of the contract, the vendor will render the following:-
 - Preventive maintenance services of the equipment's at the frequency of at least once in 03 months.
 - PM includes, cleaning, testing, carrying out repairs to a fully operational fit level.
 - In case the machine is idle for replacement of the parts, the contractor will replace the parts in reasonable time which in any case will not be more than 48 hours from the registration of complaint.



- Before taking out the equipment to Service Station / Workshop for repairs etc., a standby system of same or higher configuration should be installed at the site & permission / Gate Pass should be obtained from HITES.
- The Contractor will attend to all the calls from HITES on all working days. The
 urgent, immediate and unavoidable calls are to be attended before and after the
 usual office time and even on holidays. However, the reasonable time would be
 allowed for the specific jobs on the merits of the jobs. HITES reserves the right to
 decide any job as urgent or unavoidable depending upon the nature of the job.
- The contract will be inclusive of all spares including Complete Telephone Instrument Set, Crown change, faulty wire change, Rozzet Box, KTS repair, PBT replacement, telephone cables and consumables. All spares and consumables to be replaced / supplied should be OEM spares and must be procured from the Authorized distributors / manufacturer failing which contract is liable to be terminated.

VALIDITY OF BID:

03 (Three) months after the date of opening the same.

OTHERS:-

- It shall be responsibility of the contractor to hand over the system & accessories as shown in the CAMC in fully working condition, after the CAMC is over.
- The representative of the firm may inspect the Exchange/KTS Systems/Telephone instruments on any working day before they submit their rates for CAMC.
