

TERMS & CONDITIONS OF TENDER DOCUMENT

- a. Rate offered should be the basic rate. The rates should be quoted in **Annexure -2** attached. The party should have valid PAN, GST registrations, Import-Export Code & Bank Account in any Nationalized (or) scheduled bank & required certificate from Pollution control board,. The supporting documents to be enclosed along with the bid.
- b. If the party is in the category of MSME, the supporting documents to be submitted along with the bid to avail the applicable relaxations.
- c. 




