

Amendment No.2 October 7, 2015

Sub: Amendment to the Tender inviting Supply of Multi-speciality drugs/ pharmaceutical products to HLL retail pharmacies in various parts of country under rate contract

With reference to the above, we here by incorporate the following amendment to the tender documents as detailed below;

- 1. The last date of date for receipt and opening of bid of the above referred tender has been amended as follows.
 - (a) Last date and time of receipt of Bids: 14-10-2015, 14.30 Hrs
 - (b) Date and time of opening Technical & Price bid: 14-10-2015, 15.30 Hrs

2. Submission of bids:

a) In view of the bidder concerns over the difficulty of delivering the hardcopies before due date of tender due to courier/postal delays, bidders are permitted to submit their bids in **soft copies (non-editable and password protected PDF format)** before the due date of the tender to the email id: **rajeshramakrishnan@lifecarehll.com**. However, the hard copies of the same shall follow and should reach at the earliest.

b) The passwords for the bids shall be sent to the same email id <u>soon after the last</u> <u>date and time of submission of bids but before the time specified for the opening</u> <u>of the bids</u>.



3. The Format-8: Checklist of documents- to be submitted is amended and the revised Format:8 is attached herewith for reference. <u>Bidders are required to</u> <u>submit the documents in the revised checklist only alongwith the Technical bid.</u>
