5. Payments will be made after satisfactory completion of work on actual measurement basis (on quarterly basis.)
6. During execution of work, the Contractor or authorized representative should be present at site.
7. **ACCIDENT & INSURANCE:**  
In case of any accident to the labours engaged by the party while executing the work, party shall be responsible for the same and shall pay the compensation as per the WCA and the rates framed their under.

10. The paints used must be Asian/Berger/Nerolac/Surfacem/Snowcem make only.
11. The material used should be of approved make & if required the samples should be submitted for approval.
12. If water and Electricity supplied by HLL Lifecare Ltd. will be charged 1% each on every consumption items.
13. All works to be carried out as per instructions of Engineer-in-Charge.
14. Security Deposit @ 5% of total amount of work executed will be retained from each bill. SD will be refunded after SIX months from date of completion of contract.
