#### **TERMS & CONDITIONS**

- 3. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser accordingly.
- 4. The bids will be evaluated by taking the total quoted amount for all items.
- 5. The prices quoted shall be valid for a period of **90 days** from the date of opening of bids.
- 6. The items should be delivered within **2 weeks** from the date of placement of order.
- 7. Penalty at 0.50 % of the total Purchase Order value for each week of delay or part thereof subject to a maximum of 5 % is applicable for delayed delivery.
- 8. Necessary statutory documents and media CDs/DVDs are to be supplied along with the product.
- 9. The product license shall be supplied as paper license (volume license) with necessary media.
- 10. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 11. The bidder who requires any clarification on the tender shall notify the undersigned through e-Mail at sivakumar@lifecarehll.com. However no post bid clarification shall be entertained.
- 12. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.
- 13. No bidder shall try to influence the Purchaser on any matter relating to its bid, from the time of the bid opening till the time the Purchase order is placed.
- 14. The supply order will be placed on the first lowest responsive bidder.

- 15. HLL will have the right to increase or decrease up to 20% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions.
