### TERMS AND CONDITIONS FOR HIRING OF PASSENGER VEHICLE FOR OFFICIAL USE ON CONTRACT BASIS

1. The filled & duly signed quotations shall be submitted to;

The last date of receipt of sealed tender is 18/06/2020, 3.00 PM and the same will be opened on 18/06/2020, 3.30 PM in the presence of interested bidders or their authorized representatives who choose to attend at the time of opening of quotation.

- 2. In the event of the date mentioned above being declared subsequently as holiday for the purchaser's office, the due date for submission and opening of bids will be the next working day at the same venue and time.
- 3. CRDC may, at its discretion, extend the date & time for the submission of bids by amending the bid documents in which case, all rights & obligations of the Purchaser & bidders shall the subject to the extended date & time.
- 4. Bids received after the deadline for submission shall not be considered.
- 5. The tenderer must be the owner of vehicles / Registered Tours and Travel Agency. In case the Registered Travel Agency is a Firm/Company the vehicle can be owned by the Firm/Company. The vehicle should be registered in 2019-2020. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.

- 6. An EMD of Rs.5,000/- (Rupees Five thousand only) per vehicle by way of Demand Draft favoring HLL Lifecare Limited, Thiruvananthapuram payable at Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.
- 7. The rate should be quoted in the enclosed format.
- 8. An amount of Rs. 10,000/- per vehicle is to be remitted as Security Deposit by the successful tenderer.
- 9. The Earnest money of successful bidder/s will be converted to Security deposit and they will be required to remit only the balance amount within seven days of finalization of tender. EMD remitted will be forfeited if the successful tenderer withdraws after opening the tender.
- 10. The Contractor shall provide the vehicle along with driver having valid license and badge, if any, good vision and good character. The vehicle provided should be in good running condition.
- 11. The rates quoted shall include wages to the driver, cost of oil, fuel, taxes, insurance, and GST. The Contractor shall solely be responsible for compliance of statutory and non-statutory requirements involved in providing the vehicle on monthly rental.
- 12. In case of any accident the contractor will be solely liable and HLL Corporate R & D Centre will not have any liability for the damages or compensation.
- 13. The contractor shall bear the cost of all the maintenance work of the vehicle provided. In case, the vehicle cannot be made available due to breakdown, Inspection etc., the contractor shall make alternative arrangements to provide substitute vehicle of the same category failing which the amount born by the company to arrange a vehicle, will be recovered from the bill of the contractor.
- 14. In case of failure in providing the vehicle for any reason, deduction will be made from his monthly bills, as penalty, in following manner;
  - a) Failure to provide the vehicle per day: Amount Rs 2500/vehicle.
  - b) Failure to provide the vehicle for half day. Amount Rs 1250/vehicle
- 15. The bidder should not offer vehicles which are already under contract with other units of HLL.

- 16. The drivers and vehicles should be covered by valid Insurance and the Payment of compensation in case of any accident or otherwise shall be the responsibility of the contractor.
- 17. No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill after statutory deductions such as GST / Income Tax. The contractor should also ensure that wages not less than the minimum wages applicable is paid to the driver. Certificate to this effect shall be submitted by the contractor along with the monthly bill. PF & ESI coverage as applicable shall be the responsibility of the contractor.
- 18. The charges for additional Kilometers, if any, will be paid every month at the rates finalized.
- 19. Failure to supply vehicles continuously for a period of seven days will be treated as breach of contract and the Security deposit will be forfeited.
- 20. The meter indicating the kilometer should be accurate and in working condition as per the regulation of the Regional Transport Authorities concerned. The kilometer reading will be recorded at the factory premises i.e. Kilometer at the time of going out of factory and at time of returning to factory.
- 21. Log book will be kept in Vehicle under the custody of the driver for recording the distances of journeys performed and will be verified on daily basis for settlement of monthly bill.
- 22. The driver shall fill in the Trip Sheet forms made available from the Security Gate.
- 23. The vehicle should be in a position to undertake even long trips both inside and outside the state at short notice, i.e. on telephonic information for which contact telephone numbers (both land line No. and mobile No. of both the contractor and the driver) are to be clearly indicated in the tender form.
- 24. The contract will be for a period of **3** years from the date of award of contract.
- 25. On awarding the contract, the contractor shall execute an agreement with HLL Corporate R & D Centre to the effect in a stamp paper equivalent to Rs.200/- (Rupees Two Hundred Only). The draft Agreement available with HR Department shall be fully understood by the tenderers before filling the tender.

- 26. The drivers of the vehicle should be well behaved and hold valid driving license. In case the company decides to change the driver, the contractor should provide substitute immediately.
- 27. The vehicles shall be available at CRDC for all the days (24 days) including Sundays & holidays and the same shall be parked at CRDC premises only. Alternate Sundays may be given off at the discretion of the company. One day will be off, preferably on Second Saturday for servicing the vehicle.

#### 28. The normal working hours will be: 7 AM to 9 PM

- 29. The vehicle will be required to run a minimum distance of about 2200 Kms. in a month and is required to *run* seven days in a week and 14 hours daily, 7 AM to 9 PM or whenever required without any additional cost. The additional kilometers if any run, will be paid at the rate agreed upon and will be disbursed on six month's block period.
- 30. The vehicle has to run as per the requirement of the company. In case of halting outside Thiruvananthapuram district an additional amount of Rs 150.00 per day will be paid as an allowance to the driver.
- 31. In the event of any dispute the same shall be referred to the Unit Head, HLL CRDC, Thiruvananthapuram. The decision of Unit Head in the matter shall be final and binding on all the tenderers/ contractors.
- 32. The company has the right to terminate the contract in case the performance of the contractor is not satisfactory, by any point of view, upon serving a 3 months' notice.
- 33. The rate finalized against the tender shall remain firm and valid for a period of **Three years** from the date of work order and no revision/escalation will be considered except in the case of increase or decline in fuel price.
