#### 1. INTRODUCTION:

This Expression of Interest (EoI) seeks response from Original Technology Manufacturer of Radiology Artificial Intelligence meeting the requirements of this EoI and are willing to be associated with HLL through a License & Technology Collaboration Agreement on long term basis to enable HLL to use the support of solution in Tele Radiology reporting service.

#### 2. About HLL Lifecare Ltd

HLL Lifecare Limited (HLL) is a Public Sector Enterprise under the administrative control of the Ministry of Health & Family Welfare, Government of India. HLL's purpose of business is "to provide quality healthcare products and services at affordable rates". In its quest to become a comprehensive healthcare solutions provider, HLL had diversified into hospital products and healthcare services, while nurturing its core business of providing quality contraceptives.

The Diagnostic Services Division of HLL-"HINDLABS", provides quality and affordable Diagnostic Services (Path lab and Imaging) to partner institutions in a Public -Public Partnership model.

HLL is having teleradiology facility and through this we are providing teleradiology reporting services to various hospitals and Imaging clinics. Our Radiologist Panel consist of eminent and experienced Radiologists with high proficiency in speciality reporting including neuro-radiology, muskulo-skeletal imaging, paediatric imaging and abdominal imaging. Hindlabs Tele-radiology is being used by its own scanning centres spread all over India, other than that various government and private institutions are utilizing our services.

#### 3. Objective of the EOI:

The purpose of this exercise is to seek proposals for shortlisting of the vendors who are capable of implementation of Artificial Intelligence in Radiology reporting to augment and enhance the speed, efficiency and productivity of Radiologist in generating of diagnostic reports.

The primary driver behind the emergence of AI in medical imaging has been the desire for greater efficacy and efficiency in clinical care. Radiological imaging data continues to grow at a disproportionate rate when compared with the number of available trained readers, and the decline in imaging reimbursements has forced health-care providers to





compensate by increasing productivity. These factors have contributed to a dramatic increase in radiologists' workloads. Studies report that, in some cases, an average radiologist must interpret one image every 3–4 seconds in an 8-hour workday to meet workload demands. As radiology involves visual perception as well as decision making under uncertainty, errors are inevitable — especially under such constrained conditions.

A seamlessly integrated AI component within the imaging workflow would increase analysis accuracy, efficiency, reduce errors and avoid missed diagnosis, achieve objectives with minimal manual input by providing trained radiologists with prescreened images and identified features. The technology of artificial intelligence and machine learning are fast emerging brands of science. Based on the proposals received, HLL will analyze the usefulness of various solutions proposed and shortlist the vendors.

#### 4. Scope of cooperation:

HLL is seeking response from Original Technology Manufacturer of Radiology Artificial Intelligence through a License and Technology Collaboration Agreement. Prospective collaborator shall be responsible for transferring necessary know-how & know-why to enable HLL to use the support of Artificial Intelligence solution in Tele Radiology reporting service. HLL intends to cater to domestic market in India as well as overseas market. Interested manufacturers meeting the Pre-Qualification Requirements (PQRs) are invited to submit their offer in response to this EoI. Upon receipt of responses against this EoI, HLL will review the responses to ascertain suitability of the offer and shortlist prospective collaborator for further discussions. Detailed discussions on commercial and other terms and conditions to finalize the Technology Collaboration Agreement (TCA) shall be held with shortlisted prospective collaborator. The detailed terms and conditions for such a paid-up license agreement shall be mutually agreed upon.

#### 5. Eligibility Conditions- Commercial

The invitation of bids is open to all entities registered in India as well as abroad, who fulfil the criteria as specified below:

a. The interested vendor should be a legal entity recognized under Indian laws and in case of a foreign company, should be registered under the laws of such foreign country and authorized to participate in Government of India bidding process by the competent authority in India.





- b. The said legal entity should have been in existence for a period of at least 2 years on the date of submission of proposal as evidenced by the documents submitted by such entity in its proposal.
- c. The Agency should have a turnover of not less than Rs. 10 Lakhs in the preceding two years. Turnover is defined as sale proceeds as per audited Profit & Loss account of the entity, submitted for last two financial years. The copies of income tax returns for preceding two years should also be submitted along with.
- d. Agencies should have experience and proven track record of providing Radiology Artificial Intelligence product / service. A statement of work undertaken along with documentary proof within last two years need to be submitted with EoI. The agency should undertake a work order value of INR.10,00,000/- in providing AI services within two years. The following documents shall be submitted as documentary proof regarding the experience.
- i. Work order copy / agreement copy from the client; and
- ii. Satisfactory certificate for the performance of product / service from the same client.
  - e. Preference will be given to the solutions which have accreditations of CE/ FDA and standardised in Indian scenario.
  - f. The Bidder shall not be black listed by any Govt. Agency.

# 6. Eligibility Conditions- Technical

#### i. Presentations and Demonstration on proposed Solution/ Methodology.

The firms shortlisted based on the eligibility criteria may be invited to make a presentation at a date & time notified by HLL. The purpose of the presentation would be to allow the participants to present their solution/methodology, experience, capabilities, infrastructure, and other key points, if any.

If commercially qualified, the qualified participants will be requested to demonstrate the performance of the proposed AI Module. HLL Will Provide 'N' numbers of DICOM images and the participant will have to test them to showcase the result. The most accurate AI Module will be selected.

ii. General Software Specification: The software solution shall comply with the following specifications.





- The solution should be web based application. It should be accessible via Internet from anywhere in the world with any browser
- Should be platform independent and should work with Windows, Linux and MAC.
- It should be work integrate with Tele PACS software.
- Irrespective of bandwidth available user should able to start viewing reports immediately after login to the system
- Offline cache: User should able to cache the data for offline viewing.
- Reporting Module should have option for attaching report as PDF and HTML Format.
- Category wise report selection option also required.
- Should support report search engine.

#### 7. General

- The deadline for submission of the EOI is 3-PM (IST) on 21-01-2020. Expression of Interest shall be submitted in sealed envelope clearly super scribing on top of envelope "EXPRESSION OF INTEREST FOR TECHNOLOGY SHARING OF ARIFICIAL INTELLIGENCE TO BE IMPLEMENTED IN THE TELERADIOLOGY."
- 2. Though the deadline for the submission is 21-01-2020 the EOIs will be evaluated as and when they are received.
- 3. All technical and commercial terms and conditions shall be decided through separate agreements on case to case basis.
- 4. At this juncture, company is open to any model-whether existing in the industry or new-for this strategic alliance. Once the EOI are received, HLL will evaluate the proposals that are in line with our interests and finalize the most suitable model for its participation in these growth businesses.
