#### **GENERAL REQUIREMENTS**

- 1. To provide required number of efficient contract workers by the contractor as and when required by the company without any delay. Failure in providing manpower in time will attract, including but not limited to, penalty and / or may result in termination of contract without prior notice or forfeiture of EMD / Security Deposit and legal action for recovery of loss or damage suffered by the company on account of failure.
- 2. The successful bidder shall ensure compliance of GMP (Good Manufacturing Practices) requirements and other statutory requirements, as applicable, suggested / instructed by HLL representative from time to time.

#### 3. SANITATION AND HYGIENE (GMP REQUIREMENT):

The successful bidder shall ensure that all persons employed by it as contract workers shall prior to such employment undergo Medical examination and shall be free from contagious diseases. Moreover, the successful bidder shall ensure the following.

- (i) Periodical medical examination is conducted at least once in a year.
- (ii) The contract workers who come in contact with the product shall wear protective devices like cap before entering to manufacturing area shall wear clean clothes.
- (iii)Smoking, eating, chewing and drinking shall be prohibited in the work area.

#### 4. **RECORDS MAINTENANCE:**

The successful bidder will be liable to keep the Attendance Register, updated, maintain Wage Register and other Statutory Registers and any other Records to be maintained as required by the HLL from time to time.

- 1. The bidder shall possess valid registration under the Contract (Labour) Act, 1970. The tenderer should submit the copy of such valid registration.
- 2. The bidder should have PF and ESI and Service Tax Registration with the appropriate Authorities. The tenderer should submit the copy of EPF Registration, Service Tax Registration & PAN Card failing which tender will be rejected.
- 3. The bidder should have minimum 3 years experience in carrying out labour supply contracts and should have provided minimum 200 contract workers per day throughout the year. It should also have an average consultancy turnover over of minimum **Rs. 75.00** lacs per annum.
- 4. The techno commercial bid should accompany documents proof / copies with respect to work experience and statutory registration(s) of the bidder.
- 5. The bidder shall have to provide performance security vide DD/Bank guarantee from any nationalized/scheduled bank for an amount of 5% of the value of the contract before commencement of the work within 21 days from the date of award of contract. The performance security shall be valid till the completion of contract.
- 6. #### **TERMS AND CONDITIONS**

- 1. The Tender should be complete in all respects. Incomplete tenders shall be rejected.
- 2. Unsealed tenders received shall be rejected and this shall be at the sole risk of the bidder.
- 3. HLL Lifecare Ltd. shall have the right to inspect the existence and correctness of the details claimed in the techno commercial bid, to determine the eligibility of the bidder prior to opening of price Bid or the award of work and the bidder shall extend all cooperation for this. If any information provided in the Techno Commercial Bid is found false or not correct at the stage of inspection, the Bidder shall be disqualified. If any information provided in the Techno Commercial bid is found false at any point time during the contract period, the same shall result in termination of contract with the bidder, disqualification of the bidder from future tendering, forfeiture of EMD paid and security deposit and payment of compensation by the contractor towards loss or damage caused to the company on account of making false claims.
- 4. The bidder who does not meet the minimum eligibility criteria shall be considered as *Technically disqualified*. Their price bid shall be returned unopened to such bidder(s).
- 5. Workers engaged by the successful bidder for undertaking the work(s) as provided in the tender document, will be the employees of the contractor at all times and for all purposes and shall not be deemed to be the employees of HLL at any point of time. It is further clarified that the labour so employed by the contractor with HLL, shall not stand at any point of time, in an employer and employee relationship with HLL.
- 6. The persons engaged for this work by the contractor should be in age group between 20 and 45 years and meeting the qualification criteria(s) as specified in SCHEDULE-A of this bid document.. The bidder shall arrange medical check up for them in the manner mentioned elsewhere in this tender, prohibit smoking, chewing etc. at work place and shall comply with all relevant legal & Good Manufacturing Practices provisions.
- 7. The contract awarded shall not be subcontracted to any other person/organization. In case HLL Lifecare finds any point of time during the period of contract, that the contract undertaken by the contractor has been subcontracted, the same will be treated as violation of the agreement, liable for legal action, termination of contract, forfeiture of EMD, security deposit and disqualification from future tenders to HLL.
  - 8. That, the contractor shall carry out all the instructions issued by HLL through any of its authorised officer from time to time. HLL will maintain instruction register at each plant

and officer should record instruction in the same with due acknowledgement from the contractor or from his representative (s).

- 9. The successful bidder shall be responsible for supplying the necessary labourers in order to execute the work as per the instruction of HLL Lifecare Ltd. and such grounds of non availability of labourers due to inclement weather condition or others suggested by the contractor shall not be taken as valid ground for non-execution of the work and will be deemed as breach of contract and the successful bidder shall be liable to compensate the loss as would be assessed by HLL Lifecare Ltd. for such non-execution and the amount so computed can be set aside against the dues of the contractor with the Corporation. In addition, HLL Lifecare Ltd. may forfeit the entire security deposit or part thereof for such breach of contract.
- 10. It is the responsibility of the contractor to maintain a register containing the details of engagement of the labourers at work site daily and produce before the authorised person of HLL Lifecare Ltd. for verification etc. The contractor should make arrangement for issue of identity cards to the labourers engaged by him if it is so required. The contractor shall maintain registers and records as required under Contract Labour Act and rules thereof and such labour laws as applicable.
- 11. The contractor is liable to deposit the EPF/ESI/LABOUR WELFARE amount monthly under intimation in details along with ECR to the officer authorised by HLL Lifecare Ltd. in accordance with the EPF/ESI/LABOUR WELFACRE Act. The deposit proof shall be supported with challan along with ECR detail in respect of labours provided to HLL only.
- 12. In case the contractor fails to make payment of wages to the contract labour within the prescribed period or makes short payment of the wages in full or unpaid balance due, as the case HLL Lifecare Ltd. will have right to recover the said amount from the contractor either by deduction any amount payable to the contractor or as a debt payable by the contractor.
- 13. The contractor shall not be entitled to claim any compensation for idling its labourers for non-working of plant due to natural calamities, mechanical, electrical break-down and break-down for repair and maintenance etc. In case of breakdown needing more than 10 days continuously for repair and maintenance or for any other ground, HLL Lifecare Ltd. shall intimate the contractor within three days from the date of occurrence of such breakdown.
- 14. That any difference or dispute which will arise in consequence of execution of work thereof shall be decided by arbitration appointed by the Chairman & Managing Director of HLL Lifecare Ltd. and decision of the Arbitrator shall be final and binding on the parties. The contractor shall have no objection to such reference to the arbitrator or any ground what so ever.

In the event of any dispute no causes of action shall arise in their favour of the contractor to approach any court of law unless he/ she have resorted to and exhausted the remedy available through arbitration as envisaged above.

The parties will enter to agreement with the embodied terms and conditions shall be deemed to have been entered into at New Delhi and the Court at New Delhi alone will

have the jurisdiction in such matter. Neither party shall be entitled to file any proceeding in any other Court of Law.

#### 16. PRICE BID

The Bidders shall quote to HLL Lifecare Ltd. the lowest competitive rate for ONE PERSON for One Day of each category.

- Before quoting the rate in the price bid, the bidder should study well the nature of contract and responsibilities specified in this tender. Thereafter, the bidder shall quote separately for each category under different heads in the prescribed price format in line with Payment of Minimum Wages Act 1948 as applicable to the State of Haryana to be paid to the workers W.E.F. *01.01.2015* contractor's PF and ESI contribution, Income Tax and Service Tax as applicable, Insurance coverage for his/her/its workers, Services charges and other statutory obligation.
  - HLL shall have no obligation with regard to statutory or other welfare measures of the contract workers provided by the contractor. The contractor shall bear the entire responsibility and risk to pay wages or make payment(s) and other statutory levies in respect of the manpower provided by it during the tenure of contract.
