TERMS AND CONDITIONS FOR HIRING OF VEHICLE FOR OFFICIAL USE ON CONTRACT BASIS

- 1) The tenderer must be the owner of vehicle. The vehicle should be registered after January 2012. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.
- 2) <u>The bidder should not offer vehicle which are already under contract with</u> <u>other units of HLL or with any other organization.</u>
- 3) An EMD of Rs.5,000/- (Rupees five thousand only) by way of Demand Draft drawn in favour of HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.

- 12) No advance will be given for the service provided by the contractor and the payment will be made only on monthly basis on presentation of bill and after statutory deductions such as Income Tax. The contractor should also ensure that minimum wages is paid to the driver and a certificate to this effect shall be submitted by the contractor along with the monthly bill.PF & ESI coverage applicable shall be the responsibility of the contractor.
- 13) The charges for additional Kilometers, if any, will be paid every month at the rates finalized.
