# <u>Tender for selecting the external reference laboratory for outsourcing of laboratory tests including Specialty Clinical Tests from HLL Hindlab Kozhikode.</u>

It has been decided to invite bid from various Laboratories for identifying the **outsourcing partner** for performing laboratory tests including Specialty Clinical tests for our Hindlabs Laboratories located at HLL Hindlabs, Kozhikode, Kerala, India.

#### **Background**

HLL Lifecare Limited (HLL) is a Government of India enterprise under the Ministry of Health and Family Welfare. HLL, a world leader in contraceptives, has grown into a comprehensive healthcare company. A parallel world of services exists under HLL Lifecare Ltd apart from its contraceptive products. Healthcare Services Division offers support to partnering institutions in the areas of Laboratories services, pharmacy and other specialist services.

Hindlabs is offering a range of Laboratories services including Clinical Laboratory services, X-Ray, Ultrasound, Colour Doppler, Echocardiography, ECG etc at various locations across India.

#### I. Objective

HLL is setting up Laboratories centres 'HINDLABS' in various Govt. & Non-Govt. Institutions across India. The centre will provide quality Laboratories Services - in Biochemistry, Serology, Pathology, Microbiology etc in the various Govt. & Non-Govt. institutions at an economical rate. The centre will mainly cater to the requirements of all departments of hospital. We expect the companies to give maximum discount in their offer as a special case as HLL intends to pass on maximum benefit to the patient.

Currently Hindlabs are operating At 129 locations across India. These labs are located in the states Kerala, Chattisgarh, Maharashtra, Assam, Tamil Nadu, West Bengal and Delhi.

HLL Invites bids from eligible parties for providing outsourced lab test services for HLL Hindlab located at Kozhikode, Kerala.

#### **INSTRUCTIONS TO BIDDER**

Bid Fees: - The bidders shall submit a Bid Fee of Rs.10, 000/- along with their bid. The bid fee shall be submitted in the form of Demand Draft issued by a nationalized/ scheduled bank and drawn in favour of HLL Lifecare Ltd. payable at Trivandrum.

Documents in Electronic form will not be accepted. Tender should be submitted in two parts, Part – I (Technical Bid) & Part – II (Financial Bid). Envelop of Part – I should be super scribed as "Tender for selecting the external reference laboratory for outsourcing of laboratory tests including Specialty Clinical Tests from HLL Hindlab Kozhikode Part – I Technical Bid" and Envelop of Part – II should be super scribed as "Tender for selecting the external reference laboratory for outsourcing of laboratory tests including Specialty Clinical Tests from HLL Hindlab Kozhikode Part – II Financial Bid". These two covers shall be put in one single sealed cover super scribed "Tender for selecting the external reference laboratory for outsourcing of laboratory tests including Specialty Clinical Tests from HLL Hindlab Kozhikode. The sealed quotation should reach the above address latest by **15.00 Hrs on or before 16-11-2018**. The technical bid will be opened on the same day in the presence of Bidders or authorized representatives

The envelope should contain two separate sealed envelopes mentioned as given below.

#### **Envelope I- Technical Bid**

The following documents shall be submitted as part of technical bid:

- a) Audited Balance Sheet and P/L Account for financial year 16-17, 17-18
- b) Certificate of Annual turnover from Clinical Laboratory services from a Chartered Accountant.
- c) Details of the clinical laboratory departments, respective equipment with make and models installed in department wise as per Annexure-7 format.
- d) Details of manpower employed as per Annexure- 8
- e) Sales Tax Registration Certificate/Service Tax Registration
- f) Income Tax PAN number
- g) Technical details, relevant literature or any other information about the Laboratory.
- h) Experience & Track record of the bidder
- i) Copy of Current NABL /CAP/JCI and other accreditation certificate
- j) Address and location of the Testing Laboratory of the bidder which will service the requirement of respective Hindlabs.
- k) Annexure-1 duly signed and sealed.
- The bidder shall submit the copy of the tender document and addenda thereto, if any, with each page duly signed and stamped to confirm the acceptance of the entire terms & conditions of the tender.

The bid will be summarily rejected in case any or all of the following:

- 1. The bid with conditional and ambiguous clauses.
- 2. The bid without EMD
- 3. The bid without bid fee

The tender of any tenderer, who has not complied with one or more of the conditions of prequalification criteria and / or fail to submit the required documents in prescribed format as mentioned / or required / or conditional tender are liable to be summarily rejected.

#### **Terms and Conditions**

- The bidder may specify the in house facilities as well as the outsourcing tests separately.
- The bidder has to declare the facility (which is NABL accredited) at which they will outsource the samples, if required.
- The bidder should have a valid MoU with the Outsourcing lab for sending the samples to that particular lab
- Should be open to any number of visits by the HLL representatives for inspection/evaluation of quality of services.
- The bidder shall quote the flat discount percentage for the tests given in Annexure 3 in the format specified in Annexure 5.
- The test rates once agreed upon should not be revised during the period of the contract. The selected bidder has to sign an MoU with HLL which will include the final rate for Individual tests. The final rates for individual test shall be derived based on the discount percentage offered for the tests as mentioned in Annexure 3.

For Example if the flat discount percentage provided for the tests mentioned in ANNEXURE 3 is 50 %, the final rate for test as per Serial No: 1 Urine routine- pH, Specific gravity, sugar, protein and microscopy =  $29 - (29 \times 50/100) = 14.50$ .

 Reports should be available online for 15 days. After 15 days the report shall be available in archives section for retrieval.





- The bidder needs to ensure that print out of the reports of the tests being performed by them can be taken in the letter head of Hindlabs.
- Lab shall provide all collection materials for samples sent to them. Collection material should be approved by Hindlabs.
- The Main/mother lab of the bidder must be NABL or CAP or JCI accredited. Preferably, they should have minimum two of their branches or minilabs accredited.
- The outsourcing partner shall post a competent person wherever intimated irrespective of load by HLL for sample collection, sample dispatch, report dispatching and data entry activities.
- Bills for testing should be provided on a monthly basis with the actual rates as mentioned in the tender document (Rates after quoted percentage of discount) and the TAT details need to be incorporated in the Invoices for individual samples. If invoices are being produced as per the above requirement, payment will be made within 30 days from the receipt of the invoice.
- The samples shall be collected from the labs 2-4 times daily depending upon our requirements. For emergencies the bidder need to collect the samples On-call basis.
- The bidder should not have been debarred or blacklisted by any Central / State Government Departments of India (The bidder has to submit a NON Conviction Certificate as per ANNEXURE 9).
- The bidder should be able to provide pan India services as required by HLL.
- The bidder has to provide willingness that where ever bidder is not having their laboratory presence, they will make arrangements to take care of the outsourced tests of HLL Hindlabs.
- In general all the routine tests as per the Annexure-4 need to be reported within 4-6 hours from the time of collecting the sample. For example, the samples collected up to 2:00 PM need to be reported before 8:00 PM. This is applicable till the sample collection up to 4pm. The samples collected after 4:00 pm need to be reported within 8-12Hrs and the online report should reach to our lab.
- If there is any variation in the TAT and if the delay is 1 hour, then 10% of the test cost will be deducted.
- The successful bidder has to sign the agreement with HLL and in that the mutually agreed TAT for each tests need to be specifically mentioned
- If HLL is requesting for Home collection facility, then the bidder need to be provided the same for the patients with billing value more than Rs 500.00
- If the bidder can perform tests other than those mentioned in the annexures, then they can quote the prices for same in the format provided in the Annexure-6.
- During health camps conducted by HLL, the bidder need to provide sufficient manpower as desired by HLL.
- The bidder has to provide a Directory of Services with the sample details, TAT, running schedules, precautions etc.
- The samples even if outsourced, can be outsourced to only those labs with which the bidder has signed an MoU.
- If the Technical team of HLL is not satisfied with the results issued by the outsourcing Lab,
  HLL will send the samples for redoing the tests and to have second opinion. In such
  situations, if HLL found that the results send by the outsourcing partner is wrong then the
  outsourcing partner will be penalised and thus HLL will deduct an amount which is
  equivalent to Four times of the rate at which the test was performed at by the lab for HLL





#### **Envelope II- Financial Bid**

The rate quoted in Annexure 4 is to be enclosed in Envelope II. In All pages should be signed with seal.

The Bidders cannot quote for Individual locations, even if not interested to quote for all the location.

#### IV. Evaluation process:

Evaluation of the proposals shall be done in two stages as:

- (a) Stage I (Technical Evaluation): Technical evaluation of the proposals shall be done by examining the Technical Bid to determine whether they qualify the essential criteria, whether bidder has submitted the EMD with technical bid, whether all the documents as mentioned / or required in the tender to be submitted with technical bid, has been submitted, whether all the documents are in prescribed format and has been properly signed & stamped and whether the bid is complete. The bids which are not in compliance with the tender specifications will be summarily rejected.
  - After the evaluation of technical bid(s), a list of the bidder(s) who qualify the technical evaluation shall be made. Shortlisted bidder(s) shall be informed for the date, time and place of opening of the financial bid(s) and they may depute their representative/s to attend the opening of the financial bid(s). The financial bid(s) of the only technically qualified bidder(s) will be opened.
- **(b)** Stage II (Financial Evaluation): Financial bid(s) of the only technically qualified bidders will be opened for financial evaluation.
  - Refer Annexure-1 & Annexure-2 for technical bid format and Annexure-4 for financial bid format.

#### V. Earnest money deposit (EMD)

- a) The Bid shall be accompanied with an Earnest Money Deposit (EMD) of Rs 50,000.00 (Rupees Fifty Thousand Only) in the form of a Demand Draft drawn in favor of "HLL LIFECARE LIMITED, THIRUVANANTHAPURAM" issued by any Nationalized/Scheduled banks payable at Thiruvananthapuram. Payment in any other form will not be accepted. Bid submitted without EMD shall be summarily rejected. No interest shall be paid on any of these deposits.
- b) The EMD of unsuccessful bidders will be returned to them within one month of selection of successful bidder.
- c) The EMD will be forfeited if;
  - I. The bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of the tender.
  - II. The Bidder fails to accept the Purchaser's corrections of arithmetic errors in the Bidder's bid (if any),
  - III. The Successful Bidder fails to accomplish the task
  - IV. The successful tenderer fails to furnish the required performance security within the specified period.
- d) The EMD of the successful bidders will be returned in 30days from the completion of contract.

#### V. Performance Security:





The Earnest Money Deposit of the successful bidder shall submit converted to performance security.

The bidder's performance security will be forfeited in the event of a breach of contract by the bidder.

The Performance Security shall be refunded to the supplier without any interest, whatsoever, after it duly performs and completes the contract in all respects but not later than 60 days of completion of all such obligations under the contract.

#### VII. Validity:

The quoted rates must be valid for the contract period of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

In case the bidder withdraws, modifies or changes his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The bidder should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender.

**Contract Period:** - The Contract of the work will be awarded for a period of **4 months**. If the performance of the bidder is found satisfactory the contract can be extended for another 2 more months with the same rate and other conditions.

#### **VIII. Test Reports**

The test reports should be available online as per the TAT

#### IX. Rate

- a. From the discount quoted in the tender, rates of individual investigation will be arrived.
- b. Rates thus arrived from the flat discount quoted for CGHS and Non-CGHS listed tests shall be 'Firm & Final' and include all applicable taxes, transportation charges etc. No hidden charges will be accepted.
- c. The rates quoted shall be valid for the contract period from the date of signing of MOU.
- d. The financial bids will be evaluated by taking flat discount quoted on the target rates as per the formats mentioned in the Annexure-5.

#### X. Payment Terms

Bills with correct rates as per tender should be provided on a monthly basis and the payment will be made within **30 days** from the receipt of correct bills.

#### XI. Other terms

- a. If the bid opening day is declared as holiday for HLL, the bid will be opened at the next working day of HLL.
- b. Any bid received after the deadline will be rejected.
- c. HLL reserves the right to accept or reject any or all of the bids without assigning any reason whatsoever.
- d. Any dispute arising out of the tender/bid document/ evaluation of bids/issue of purchase order shall be subject to the jurisdiction of the competent court at Thiruvananthapuram only.
- e. The envelopes containing the bid shall be bearing the words "DO NOT OPEN BEFORE ....."(Here insert the time and date of bid opening).
- f. No email or fax bids will be accepted





- g. HLL Lifecare Ltd reserves the right to accept in part or in full or reject any or more quotation(s) without assigning any reasons or cancel the tendering process and reject all quotations at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s) or may call for any additional information / clarification, if so required
- h. HLL reserves the right to register and place orders on more than one supplier
- i. HLL reserves the right to extend the last date of submission of the bid.
- j. The successful bidder shall enter into a MoU with HLL based on the accepted rates for the contract period.
- k. Bids shall be submitted latest by 15:00 Hrs on 16<sup>TH</sup> November 2018 and the same will be opened at 16:00 Hrs on the same day at the above mentioned address in the presence of the representative of the bidder who choose to attend. Financial bid of the technically qualified bidders shall be opened on a later date after technical evaluation. Any changes in the Bid submission or opening dates will be updated on our website www.lifecarehll.com\tenders ONLY.
- I. Any bid received after the deadline will be rejected.

#### XII. Risk purchase

If L1 or any other parties defaults (fails to deliver goods on time) then the purchaser reserves the right to purchase the goods from L2 or higher bidder or from market at the risk and cost of supplier and if the purchase happens at a price higher than the ordered rates, the purchaser shall have the right to claim the difference upon whom order was originally placed and supplier will be under obligation to pay the same. The purchaser has the right to forfeit the performance security in the event of default. In addition the purchaser is entitled to recover the business loss suffered by the purchaser consequent to default for supplying the product.

#### XIII. Parallel rate contracts

HLL reserves the right to enter into the rate contract / parallel rate contracts with one or more parties or to place adhoc contracts simultaneously or at any time during the currency of contract, with one or more suppliers.

#### XIV. COURT JURISDICTION

This shall be subject to the exclusive jurisdiction of courts at Thiruvananthapuram, Kerala.

#### XV. Realization of L1 bid and Award of Contract:

After due evaluation of the financial bid(s), HLL will award the contract to the bidder who is offering the maximum overall Quoted Discount percentage up to three decimal points to the tests mentioned in annexure -3).
