- 3. Component drawing No: HLL/AFT/TP/05/2015, Rev. No.: 01
- 4. Material of the component: Medical grade soft PVC, Moulding grade, shore A-Hardness- 72 to 78. Raw material for mould trials will be supplied by HLL.
- 5. Type of mould: 3 plate side core mould (the component must be fully accommodated in the split cavity (side cores). High quality tool steel shall be used for the fabrication of side cores and hardness shall be greater 55 HRC
- 6. Gate design: Submarine gate



4. PRICE:
