- 1. The respective bidder should be an authorized partner/supplier for Microsoft Products for which authorization letter (to be addressed to HLL) is to be submitted along with the bid. The bidder may also attach the copies of Purchase Order for the supply of the same.
- 2. The prices should be quoted as per the format for price schedule enclosed as **Annexure I.**
- In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser accordingly.
- 4. The bids will be evaluated by taking the total quoted amount for all items.
- 5. The prices quoted shall be valid for a period of **90 days** from the date of opening of bids.
- The items should be delivered within 3 weeks from the date of placement of order.
- 7. Penalty at 0.5% per week's delay subject to maximum of 5% is applicable for delayed delivery.

- 8. Necessary documentations/CDs/DVDs are to be supplied along with the product.
- 9. Statutory documents like licenses if any should be supplied along with the product.
- 10. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 11. The supply order will be placed on the first lowest responsive bidder.
- 12.HLL will have the right to increase or decrease up to 20% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions.
- 13. Payment will be released within 30 days from the date of supply and acceptance by HLL. For claiming the payment, the following documents are to be submitted.
