- 6. The items should be delivered within **3 weeks** from the date of placement of order.
- 7. Penalty at 0.5% per week's delay subject to maximum of 5% is applicable for delayed delivery.

- 8. Necessary documentations/CDs/DVDs are to be supplied along with the product.
- 9. Statutory documents like licenses if any should be supplied along with the product.
- 10. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 11. The supply order will be placed on the first lowest responsive bidder.
- 12. HLL will have the right to increase or decrease up to 20% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions.
- 13. Payment will be released within 30 days from the date of Installation. For claiming the payment, the following documents are to be submitted.
