Specifications of Packing

The goods should be securely packed to withstand all hazards of transport. The packing and marking should be strictly as specified in the Specifications (IP). Loose tablets (without strips) should not be supplied. Packing materials shall be as per the standards in vogue.

3. ELIGIBILITY CRITERIA FOR BIDDERS

For a manufacturer:

- 1. Valid pharmaceutical product manufacturing license (Self Attested Photo copy)
- 2. Revised Schedule-M GMP certification for individual products (Self Attested Photo copy)
- 3. Valid product permission for each of the quoted product (Self Attested Photo copy)
- 4. All the documents as per format 1 to 9 of this tender document
- No conviction certificate issued within last six months.
- 6. Primary manufacture/authorized agents are allowed to participate in the Tender. Manufacturer's authorization form in original may be submitted by participating authorized agents.

(Bidders who had participated in our tenders and submitted the documents above are exempted from submitting the same for this tender. The same shall be indicated in your covering letter)

For a distributor:

- 1. Valid drug license from the competent authority
- 2. TIN, VAT Registration & PAN (Self Attested Photo copies)



OTHER DOCUMENTS REQUIRED WITH TECHNICAL BID

- 1. Power of Attorney for signatory of Bid in Rs 100/- stamp paper duly notarized.
- 2. Check list as per format 8
- 3. The bidder should furnish certificate that the medicines / drugs supplied would be of standard quality / quantity manufactured as per IP / BP / USP / NFI or equivalent specification. If some items do not fall under the purview of IP / BP / USP / NFI or equivalent specification, the bidder shall enclose a letter certifying that following items do not fall under the purview of IP / BP / USP / NFI or equivalent specification.



4. GENERAL SCOPE

- i. Supply of Pharma medicine to Retail pharmacy proposed to be opened at various parts of country.
- ii. Supply the product to HLL's store located anywhere in India.
- iii. Ensure strict compliance to all statutory regulations with furnishing of a "Certificate of Analysis" confirming to IP for each batch of all products purchased from the party.
- iv. These medicines will carry all statutory details. Any special marking if required will be indicated later to the successful bidder.

5. GENERAL INSTRUCTIONS TO BIDDERS

1. Ethical Standard

Bidders are expected to observe the highest standard of ethics during the procurement and execution of this Contract. In pursuit of this policy, HLL will reject a proposal for award if it determines that the Bidder being considered for award has engaged in corrupt or fraudulent practices in competing for the Contract

For the purposes of this provision, the terms set forth below are defined as follows:

- i) Corrupt practice: means the offering, giving, receiving, or soliciting of anything of value to influence the action in the procurement process or in Contract execution; and
- ii) Fraudulent practice: means a misrepresentation of facts in order to influence procurement process including collusive practices designed to establish bid prices at artificial, noncompetitive levels to deprive HLL of the benefits of competition;

2. Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Purchaser will in no case be responsible or liable for those costs.

3. Clarification of Bidding Documents

- i) A prospective Bidder requiring any clarification of the Bidding Documents may notify the Purchaser in writing, or by fax at the purchasers mailing address indicated in the Invitation for Bids. The Purchaser will respond in writing to any request for clarification of Bidding Documents, which it receives not later than a day prior to the deadline for submission of Bids prescribed by the Purchaser.
- ii) During the bid evaluation, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the price or substance of the bid shall be sought, offered, or permitted.

4. Amendment of bidding documents

- At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, modify the Bidding Documents by amendments published in company website only.
- ii) The amendment will be notified in writing or by fax or by e-mail to all prospective Bidders, which have received the Bidding Documents and will be binding on them.

Preparation of Bids

5. Language of Bid

All correspondence and documents related to the bid shall be in English.

6. Documents Accompanying the Bid

The Response to mandatory requirements shall consist of:



- i) A forwarding letter indicating the submission of separate sealed Technical and Financial bids. An authorized person holding the Power of Attorney should sign the letter
- ii) Power of Attorney in Rs 100/- stamp paper duly notarized.
- iv) List of Deviations / exclusions (Format-1)
- v) Organization structure of the Bidder & escalation mechanism.
- vi) A self-declaration to the effect that the bidder has read and understood the Tender document and has agreed to abide by the Terms and conditions of the Tender.
- vii) All the documents mentioned in eligibility criteria for Bidders
- 7. For all the parts of the Bid, the Bidder shall prepare one original and copy of the bid as per Bid Data Sheet (BDS), clearly marking as "Original Bid" and "Copy" as appropriate. In the event of any discrepancy between them the original shall govern. The original and the copy of the bid, each consisting of the complete set of documents shall be signed by the Bidder or a person duly authorized to bind the Bidder to the Contract. All pages of the bid shall be numbered except for un-amended printed literature, which shall be initialed by the person signing the bid.
- **8.** The bid shall contain no interlineations, erasures, or overwriting, except to correct errors made by the Bidder, in which case the person or persons signing the bid shall initial such corrections. Price should be quoted in number & words, in case there is a mismatch between the two price quoted in words shall be considered.

9. Financial Bid

The Bid Price Schedule must be prepared in accordance with the instructions specified below:

- a) The Price must be quoted in accordance with format-3, Revised Schedule-A attached. Bid should be either typewritten or written in indelible ink. Each page of the Financial Bid should be duly signed by the bidder affixing the office seal.
- b) The soft copy of price quoted as per format-3 Schedule A in CD/DVD marked original/ Duplicate with company name should be submitted along with financial bid. In case of any discrepancy in rates quoted between hard copy and soft copy the rates quoted in hard copy will remain final and binding.
- c) The Rate Quoted per unit (landed price) must include all costs associated with the execution of the contract including taxes, levies, duties, freight, insurance etc and on F.O.R. HLL Stores, anywhere in India.
- d) The landed price shall only be considered for evaluation of bids
- e) The bidder who has quoted excise duty "Nil" and item is excisable based on change in turnover etc on award of contract, will not be eligible for revision of price inclusive of excise duty

10. Period of Validity of Bid

Bid shall remain valid up to 12 months from the date of opening the financial bid. However, HLL reserves the right to extend the Price validity by another 12 months or for further period based on mutual agreement.

- 11. Fixed prices: The prices quoted by the bidder shall remain firm and fixed during the currency of the contract which would be twelve months (can be extendible) from the date of opening of the price bid and not subject to any variations on any account during this period.
- **12. Parallel rate contracts:** HLL reserves the right to enter into the rate contract / parallel rate contracts with one or more parties or to place adhoc contracts simultaneously or at any time during the currency of contract, with one or more suppliers.



- **13. In case of Default:** The purchaser is not bound to accept the L1 offer only and circumstances warranting where L1 shows its disinterest, L2 or higher offer may be considered for acceptance.
- **14. Liquidated damages:** If the supplier fails to deliver any or all of the goods within time period specified in the supply order, HLL shall recover the liquidated damages from the bidder at the rate of 1% per week of delay of the total order value subject to maximum of 20% of the total order value.
- 15. Risk purchase: If L1 or any other parties defaults (fails to deliver goods on time) then the purchaser reserves the right to purchase the goods from L2 or higher bidder or from market at the risk and cost of supplier and if the purchase happens at a price higher than the ordered rates, the purchaser shall have the right to claim the difference upon whom order was originally placed and supplier will be under obligation to pay the same. The purchaser has the right to recover the same from the performance security if the supplier does not make the payment.
- **16. Inspection:** The supplier should submit the internal lab reports for the supplies made to the HLL. The purchaser reserves the right to sample check the consignment at the time of delivery for which cost shall be borne by the supplier (pre-dispatch inspection)
- **17. Shelf Life:** The supplies of medicines / drugs should be from fresh stock only. At the time of receipt of medicines, they should have the latest manufacturing date and minimum remaining expiry period should be 3/4th of the life of the drug.
- **18. Guarantee/Warranty:** All the losses due to biological degradation of medicines during the life of potency should be made good by supplier. The drugs supplied shall have a warranty of 1 year from the date of supply. In the event of any rectification of the defect or replacement of any defective goods during the warranty period, the same shall be done by supplier free of charge.
- **19. Indemnity:** The supplier hereby indemnifies HLL Lifecare Ltd and will always keep it indemnified against all terms, claims, demands, losses, costs, expenses etc. arising out of supply of drugs or in respect of this contract.
- **20. Short supply:** if any shortages in sealed boxes are detected then supplier should be held responsible. In such a case, the supplier will have to make good of the loss or refund the payment for such quantity equal to its F.O.R. value if the payment is already made. If the payment is not made, purchaser will have right to deduct the payment for the equivalent F.O.R. value corresponding to quantity found short.
- 21 Fall Clause: i) The prices charged for the products supplied under the contract by the supplier shall in no event exceed the lowest price at which the supplier sells the products or offers to sell the products of identical description to any person(s) / organization(s) including the purchaser or any department of the central government or any department of a state government or any statutory undertaking of the central or a state government, as the case may be, during the period till performance of all supply orders placed during the currency of rate contract is completed.
 - ii) if any time during the said period, the supplier reduces the sale price, sells or offers to sell such stores to any person(s)/ organization(s) including the purchaser or any statutory undertaking of the central or a state government, as the case may be, at a price lower than the price chargeable under this contract, he shall forthwith notify such reduction or sale or offer to sale to the purchaser and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale stand correspondingly reduced. The above stipulation does not apply to:
 - a) Export/deemed export by the supplier
 - b) Sale of goods at lower price on or after the date of completion of sale /placement of order of goods by the authority concerned, under the existing or previous rate contracts



as also under any previous contracts entered into with the central or the state government department including new undertaking (excluding joint sector companies and or private parties) and bodies.

- **22. Flexibility of prices:** The purchase has option to re-negotiate with rate contract holder to bring down the rate contract prices whenever market fluctuations affect the prices abnormally.
- **23. Goods replacement:** Supplier should replace the non moving goods given by HLL before 6 months of their expiry.

Submission of Bids

24. Sealing and Marking of Bids

- i) The Bidder shall prepare and seal in **separate packets** the following in duplicate for:
 - Technical Bid
 - Financial Bid

Packet will contain the Technical Bid and Price Bid in **separate envelopes**, duly marking the envelopes as **TECHNICAL BID** and **PRICE BID** for Pharmaceutical Products.

All the above packets shall then be sealed in an **outer envelope**, duly marking the envelope as **BIDS FOR** IFB No HLL/MKTG/MSD/2015-16/01 DT. 23.09.2015.

- ii) The inner and outer envelopes shall be addressed to HLL at the address given in the bid data sheet and
- a) Bear the Contract name, the Invitation for Bids title and number, and the statement "DO NOT OPEN BEFORE" 15.00Hrs ON 26.09.2015. (Mention the date of opening of the bid as given in the tender documents).
- b) The inner envelopes shall also indicate the name and address of the Bidder so that the bid can be returned unopened in case it is declared late.
- c) If the outer envelope is not sealed and marked as required HLL will assume no responsibility for the bids misplacement or premature opening.

iii) Deadline for Submission of Bids

Bids must be received by HLL at the address specified in the bid not later than the time and date stated in the bid. HLL may, at its discretion, extend this deadline for submission of bids in which case all rights and obligations of HLL and Bidder thereafter shall be subject to the deadline as extended.

iv) Late Bids

Any bid received by HLL after the bid submission deadline prescribed by HLL in the bid, will be rejected and returned unopened to the Bidder.

v) Modification and Withdrawal of Bids

Bids once submitted should not be modified. However in exceptional cases where modification is inevitable, the following procedure for the same should be adopted.

- i) Modification will be permitted only if a written notice of the same is received by HLL prior to the deadline prescribed for bid submission.
- ii) The Bidder's modifications shall be prepared, sealed, marked, and dispatched as follows The Bidders shall provide an original and one copy of any modification(s) to its bid, clearly identified as such, in two inner envelopes duly marked BID MODIFICATIONS ORIGINAL and BID MODIFICATIONS COPY. The inner envelopes shall be sealed in an outer envelope, which shall be duly marked BID.
 - i) A Bidder wishing to withdraw its bid shall notify HLL in writing prior to the deadline



prescribed for bid submission. The withdrawal notice shall:

Be addressed to HLL at the address named in the bid data sheet and bear the Contract name, and the words BID WITHDRAWAL NOTICE. Bid withdrawal notices received after the bid submission deadline will be ignored and the submitted bid will be deemed to be a validly submitted bid.

- ii) No bid may be withdrawn in the interval between the bid submission deadline and the expiration of the bid validity period specified.
 - vi) In the event of the date specified for bid receipt and opening being declared as a closed holiday for purchaser's office, the due date for submission of bids and opening of bids will be the following working day at the appointed times.
 - vii) The purchaser may, at its discretion, extend this deadline for submission of bids by amending the Bid Documents or any other reasons, in which case all rights and obligations of the Purchaser and Bidder previously subject to the deadline will thereafter be subject to the deadline as extended, in our website.

Purchaser will not be held responsible for the postal/courier delay, if any, in the delivery of the bidding document or the non-receipt of the same. Bids sent by Telex/Fax/Telegraph will not be accepted.

The company reserves the right to club or split the items of works, change the qualifying criteria at their discretion and to reject the bid or cancel the tender without assigning any reason thereof.

25.Bid Opening and Evaluation

viii) Opening of Bids by HLL

- i) Bids received before the dead line of the submission of the bid will be opened on the date and time of opening mentioned in the Bid Data Sheet (BDS).
 - Bidders wishing to be present at the time of such opening may send their duly authorized representative. Only Technical Bids will be opened on that day.
- ii) The purchaser will scrutinize the technical bid for compliance to the specifications and documentation requirement as per the bid document. Purchaser may depute its competent officers to the premises of the bidder qualified on the basis of technical scrutiny, for on-site evaluation of the claims made in the technical bid, if deemed appropriate on purchaser's sole discretion. The bidders will be short-listed on the basis of responsiveness of technical bid as well as report of on-site technical evaluation. The price bid of the bidders who are disqualified at the technical scrutiny and on-site evaluation will be returned un-opened. The short listed bidders will be informed about the time, date and venue of the price bid opening.

26. Preliminary Examination of Bids

- i. HLL will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required securities have been furnished, whether the documents have been properly signed, and whether the bids are generally in order. HLL will ensure that each bid is from an eligible Bidder.
- ii. Arithmetical errors will be received on the following basis. If there is a discrepancy between the unit price and the total price, which is obtained by multiplying the unit price and quantity, or between subtotals and the total price, the unit or subtotal price shall prevail, and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail. If a Bidder does not accept the correction of errors, its bid will be rejected.



- iii. HLL may waive any minor nonconformity, or irregularity in a bid that does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder.
- iv. Prior to the detailed evaluation, pursuant to Eligibility criteria for bidders, the purchaser will determine the substantial responsiveness of each bid to the bidding documents. For purposes of these clauses a substantially responsive bid is one which conforms to all the terms and conditions of the bidding documents without material deviations. Deviations from or objections or reservations to critical provisions such as those concerning Warranty, Force Majeure, Applicable law and Taxes and Duties will be deemed to be material deviation. The purchaser's determination of a bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. If a bid is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the bidder by correction of the non-conformity.
- v. HLL may waive any minor nonconformity, or irregularity in a bid that does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder.
- vi. For price comparison during evaluation the net unit rate inclusive of all taxes, levies, freight & insurance (column e of Format 3) will only be considered
- vii. For the Financial Bid, only those Bidders qualifying in the Technical bid will be considered.

27. Clarifications on Bids

During the bid evaluation, HLL may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the price or substance of the bid shall be sought, offered, or permitted.

28. Contacting HLL

- i) From the time of bid opening to the time of Contract award, if any Bidder wishes to contact HLL on any matter related to the bid, he shall do so in writing.
- ii) If a Bidder tries to influence HLL directly or otherwise, interfere in the bid evaluation process and the Contract award decision, his bid will be rejected.

29. HLL's Right to Accept or reject any or all Bids

HLL reserves the right to accept or reject any bid or to annul the bidding process and reject all bids at any time prior to Contract award, without assigning any reason thereof.

30. Notification of Award

Prior to the expiration of the period of bid validity, HLL will notify the successful Bidder in writing that its bid has been accepted.

The notification of award will constitute the formation of the Contract.

31.Signing of Contract

- i) At the same time as HLL notifies the successful Bidder that its bid has been accepted, HLL will send the Bidder the Contract Form provided in the Bidding Documents, incorporating all agreements between the parties.
- ii) Not more than ten (10) days following receipt of the Contract Form, the successful Bidder shall prepare the contract agreement on a Non Judicial stamp paper of Rs 100/-, sign, date and return it to HLL.

In case, the successful bidder does not do so, HLL in its discretion may cancel the bid of the successful bidder and may accept the bid of the next higher bidder.



6. CONDITIONS OF THE CONTRACT

1. Settlement of Disputes

1.1 Arbitration shall not be a means of settlement of any dispute or claim arising out of the contract relating to the work. Any disputes or difference arising between the parties with respect to the performance of any part of this agreement or anything connected therewith, etc shall as far as possible be mutually settled by the process of dialog and negotiation.

1.2 Conciliation/Arbitration

Any disputes or differences or questions or claims arising under or relating to a concerning or touching this agreement shall be referred for arbitration in accordance with the provisions of the Arbitration and Conciliation Act 1996.

The arbitration proceedings shall be held at Thiruvananthapuram. The award passed by the arbitrator shall be final and binding on the parties hereto.

The conduct of such arbitration shall be in English

1.3 No suspension of work

The obligations of HLL and the bidder shall not be altered by reasons of conciliation/arbitration being conducted during the progress of works. Neither party shall be entitled to suspend the work on account of conciliation/arbitration nor shall payments to the bidder continue to be made in terms of the contract.

1.4 Award to be binding on all parties

The award of the Sole Arbitrator, unless challenged in court of law, shall be binding on all parties.

1.5 Jurisdiction of Courts

The Courts at Thiruvananthapuram alone shall have jurisdiction in respect of settlement of any matter arising out or in connection with the contract.

2. Time for Commencement and Acceptance

The **successful** Bidder shall submit the final samples within stipulated period given by HLL later.

3. Bidders Responsibilities

- 3.1 The Bidder shall be responsible for timely provision of all resources, information, and decision making under its control that are necessary to reach a mutually Agreed and Finalized Plan within a period of two (2) weeks from the date of issue of Letter of Acceptance.
- 3.2 The bidder shall acquire in its name all permits, approvals, and/or licenses from all local, state, or national government authorities or public service undertakings that are necessary for the performance of the Contract.
- 3.3 The bidder shall comply with all laws in force in India. The laws will include all national, provincial, municipal, or other laws that affect the performance of the Contract and are binding upon the bidder. The Bidders shall indemnify and hold harmless HLL from and against any and all liabilities, damages, claims, fines, penalties, and expenses of whatever nature arising or resulting from the violation of such laws by the bidder or its personnel. Except that caused by HLL.
- 3.4 The bidder shall provide and employ only such personnel who are skilled and experienced in their respective callings and supervisory staff who are competent to adequately supervise the work at hand.



In particular, the key personnel namely the Project Leader, Quality Assurance personnel any Specialist/Analysts required as appropriate, need to have sufficient experience in terms of relevance and number of years required for the contract.

- 3.5 If for any reason beyond the control of the bidder, there arises a need to replace any personnel, the Bidders shall provide a replacement person of equivalent or better qualification and experience, subject to the written approval of HLL.
- 3.6 The bidder/bidders representatives in HLL shall bind to obey the rules and regulations of HLL.
- 3.7 The bidders have to supply the goods within 30 days (Thirty Days) from the date of placing the confirmed order with the supplier. Supplies made shall be in strict conformance with the stipulations of rate contract, Notification of Award and the respective Purchase orders.
- 3.8 Any product related cases shall be borne by the manufacturer.

Payment

4. Terms of Payment

100% payment to the supplier will be processed after:

- 1. Receipt of material at HLL nominated store location & acceptance of same by stores in good condition.
- 2. Receipt of the positive test report by HLL from external laboratory. On confirmation of positive test report, payment will be made through RTGS only.
- 3. Receipt of Documents as detailed below are required for payment from supplier's end.

Documents required for payment from supplier:

- 1) Internal Lab reports from the manufacturer lab
- 2) Consignee receipt certificate
- 3) Invoice, packing list in triplicate giving details of contents and suppliers invoice
- 4) Certificate that goods are of standard quality and manufactured as per IP/NFI/BP/USP or equivalent specification norms, confirming to HLL indent.

5. Delivery Schedule

Goods to be supplied within 30 days (Thirty Days) from the date of placing the confirmed order with the supplier.

6. Taxes and Duties

The Bidder shall bear and pay all taxes, duties, levies, and charges assessed on the bidder by all municipal, state, or national government authorities, in connection with the Goods and Services supplied under the Contract. Income Tax and Other Taxes as applicable at the time of execution of job or any other government-imposed liabilities would be deducted from each bill submitted by the bidder.

7. Intellectual Property

All rights including the Intellectual Property Rights subsisting in any material including any tools, utilities or methodologies belonging to the Bidders and used to perform the obligations under this Agreement shall remain vested in the Bidders (the Bidders Properties) and any additional or new inventions made in the course of performance of services shall belong to HLL.

8. Confidential Information

HLL and the Bidder (the Receiving Party) shall each keep confidential and shall not, without the written consent of the other party to this Contract (the Disclosing Party),



divulge to any third party any documents, data, or other information of a confidential nature (Confidential Information), that has been marked Confidential (Confidential Information).

9. Force Majeure

Force Majeure shall mean any event beyond the reasonable control of HLL or of the Bidders, as the case may be, and which is unavoidable notwithstanding the reasonable care of the party affected and shall include, without limitation, the following

- i) War, hostilities, or warlike operations (whether a state of war be declared or not), invasion, act of foreign enemy, and civil war;
- ii) Rebellion, revolution, insurrection, mutiny, usurpation of civil or military government, conspiracy, riot, civil commotion, and terrorist acts;
- iii) Strike, sabotage, lockout, embargo, import restriction, industrial dispute, epidemics, quarantine, and plague;
- iv) Earthquake, landslide, volcanic activity, fire, flood or inundation, tidal wave, typhoon or cyclone, hurricane, storm, lightning, or other inclement weather condition, nuclear and pressure waves, or other natural or physical disaster immediately effecting project implementation;

If either party is prevented, hindered, or delayed from or in performing any of its obligations under the Contract by an event of Force Majeure, then it shall notify the other in writing of the occurrence of such event and the circumstances of the event of Force Majeure within fourteen (14) days after the occurrence of such event.

Change in Contract Elements

10. Termination

HLL may at any time terminate the Contract for any reason by giving the Bidders a thirty days (30) notice of termination

11. Termination for bidders Default

- i) If the Bidder assigns or transfers the Contract or any right or interest therein in violation of the provision of Clause 13(Assignment); or
- ii) If the bidder, in the judgment of HLL, has engaged in corrupt or fraudulent practices in competing for or in executing the Contract, including but not limited to willful misrepresentation of facts concerning ownership of Intellectual Property Rights in, or Proper authorization and/or licenses from the owner to offer, the hardware, software, or materials provided under this Contract.

12. Assignment

The bidder shall not, without the express prior written consent of HLL, assign to any third party the Contract or any part thereof, or any right, benefit, obligation, or interest therein or there under.

13. Replacement

In case of market complaints due to the quality issues in the Product the bidder shall take the sole responsibility to replace the goods in full to HLL with fresh batch of acceptable goods. An undertaking (Format-5) is to be submitted by the bidder to HLL.
