## **REQUIREMENTS**

- 1) Non reversible rotation (Unidirectional rotation)
- 2) Additional Inner door with glass to be provided.
- 3) Inner Ring Support with studs to avoid Bolts on front Plate.
- 4) Galvanized Base Channel.
- 5) Without Chemical holding Reservoir.
- 6) Chemical Dispenser / Hopper to be provided within Machine.
- Control Panel shall be provided with over load relay, fuses, preventer, Sleek Indicators and PIDS System on fibre glass, Panel Plate.
- 8) Electrical as per Electrical Inspectorate regulations.
- 9) Safety system should be provided
- 10) Heat resistance paint (2 coats), wherever applicable

## **ITEM 2: TUMBLER**

#### Inner Drum

Made out of stainless steel of 1200 mm diameter, 1000 mm length, with 6 mm diameter perforation in Triangular pitch for efficient air flow and in built U lifters of 4 Nos. The "U" lifters will be an integrated part of shell so that it will not have any weld joints.

Door for Inner drum with viewer glass will be provided which ensure 100% proof from the product being falling between the inner and outer drums.

### **Outer Drum**

Made in two halves to regulate the air supply directly and uniformly to the product in Inner drum.

### **Outer Panel**

Front panel made of stainless steel with one touch lock arrangement for easy closing and opening. Front panel with view glass arrangement.

Side panels with twin hinge arrangement doors for easy cleaning of holes from the sides.

The bottom of the front panel will be provided with viewer glass arrangement for easy visibility of powder collection in the filter arrangement.

#### <u>Structure</u>

The entire machine will be made of tubular structure of 40 mm Sq. tubes. The drive arrangement will be made out of MS Channels and MS angles.

### **Drive Arrangement**

The machine will be provided with Double stage speed reduction system for a final RPM of 35±1 from 2HP, 3 Ph, 1440-RPM TEFC Motor.

The Main Drive shaft will be provided with Pillow Block arrangement bearings for easy Maintenance.

## <u>Blower</u>

The Radial flow, Paddle type Aluminum Impeller of High speed 2 HP, 3 Ph will be provided with Damper Arrangement.

## <u>Heater</u>

The machine will be provided with Double Pass Radiator with finned tubes for effective heat transfer designed for working pressure of 10 Kg/Cm<sup>2</sup> and tested to 15 Kg/Cm<sup>2</sup>. The radiator will be of double framed for easy accessibility to all the tube joints.

## **Control Panel**

An Electrical Control Panel mounted in the top of the machine with viewer glass arrangement will be provided which will have Overload Relay, MCB, Indication Lamps etc.

The process time and rotation times can be programmed to your requirement with the help of Digital Timers provided. The display will be of digital type.

## Power Cleaning

- 1. The machine will be provided with 4 Nos vertical hinged doors on the sides for easy cleaning of powder deposited in the holes.
- Air Spray system with 6 Nos of High Speed Air Jet Nozzles will be provided in the bottom of Inner Drum.
- 3. The Bottom chamber will be provided with filter arrangement.

## **General Requirements**

- 1. All the viewer glass arrangements will be of POLYCARBONTE, the colour of which will not change in usage like that of ACRYLIC sheets.
- 2. All the holes in the inner drum will be punched ones which ensure 100% burr free holes.
- 3. The welding of stainless steel will be TIG welding which ensure the Chromium present in stainless steel in not oxidized during the welding.
- 4. All the weld joints will be smooth and ground finish, which is essential for Latex products.

## ITEM 3: SPIN DRYER

#### **Requirement**

We require two nos. spin dryers (30 kg capacity) of 3 column suspension type, with the inner surface of the volute chamber lined with SS-316, in Plant-C at our Peroorkada Factory, Thiruvananthapuram.

### **GENERAL CONDITIONS**

- Given specification are indicative only. The supplier should visit the plant and see the machines and also take their own assessments before quoting of bids. Prior permission from HLL shall be taken for visiting the plant. No photographs will be allowed inside the plant. The purchaser will not be responsible for any wrong quotes due to inadequate information.
- 2. The supplier should submit 3 copies of the following documents relevant to his scope of work, two weeks prior to the commissioning of the unit, free of cost.
  - a. Instruction/Testing/Operation manual (3 copies)
  - b. Maintenance manual/Lubrication Chart (3 copies)
  - c. All final drawings Electrical, mechanical and civil (3 copies)
  - d. Relevant Test Certificates, Guarantee Certificate for each item of equipment.
  - e. Catalogue and literature on bought outs (3 copies)
  - f. Any other related documents
- 3. The equipment should be complete with all accessories and interconnections.

- 4. Guarantee/ validation run of the machine shall be certified after 7 days of successful production from the machine, meeting the required capacity and product quality standards.
- 5. All the piping within the equipment is to be provided by the supplier. Purchaser will provide utilities, such as steam/air etc. to the battery limit of all equipment.
- 6. The purchaser will be providing the required electrical supply to the equipment. All wiring requirements with in the equipment are to be provided by the supplier as per standard.
- The equipment offered should be suitable for Indian electrical ratings as follows.
  Power supply: 200-230V, 50 Hz (Single Phase) or 400-440 V, 50 Hz (3 Phase)
- 8. Calibration certificates with traceability to National Standards shall be supplied for all the instruments coming under the scope of supply of supplier.
- 9. The supplier should submit necessary test certificates as per relevant standards of material used, free of cost.
- 10. The suppliers should submit the following documents, relevant to their scope of work, two weeks prior to the commissioning of the Unit :
  - a) All final drawings
  - b) Relevant Test Certificates, Guarantee Certificate for each material which are using for fabrication.
  - c) Any other related documents
- 11. Any deviations from the bid documents shall be clearly indicated.
- 12. The bid should be complete with all the relevant details.

## **SCHEDULE III**

## CONDITIONS OF CONTRACT

### 1) PRICE

The price quoted should be inclusive of Basic Price, all applicable taxes and duties including VAT, Entry tax, Octroi & other levies, P&F charges, loading and unloading charges, insurance, installation and commissioning charges etc. The Supplier should pay entry taxes, as applicable and should be included in the offer.

The Format for Quoting (Schedule V) shall be suitably filled as applicable. Price quoted should be firm without any escalation till the order is completely executed.

### 2) TAXES/DUTIES/LEVIES

The supplier shall be entirely responsible for all taxes including entry tax, duties, license fees, etc. incurred until successful completion of contract. All central, state, municipal taxes, duties and levies payable shall be shown by the bidder separately in the Bid. The Purchaser will issue necessary 'C' Form, if required.

#### 3) COMPLETION TIME

The item/s should be delivered & installed within **10 WEEKS** from the date of issuing the Letter Of Intent or Work Order.

#### 4) GUARANTEE PERIOD

The Guarantee against any possible manufacturing defects shall be given for a period of 18 months from the date of supply and inspection of the item at HLL site or 12 months from the date of installation, whichever is earlier.

#### 5) SPECIAL INSTRUCTIONS

a) The bidder shall visit the site before quoting for the work.

b) The work should be carried out in truly professional manner, neatly finished with proper line, level and plumb. Cleanliness and finishing of the job is of utmost importance. Hence the job should be done most carefully with best workmanship. For all finishing jobs samples should be approved from the Purchaser/Owner before completely executing the work.

c) The Purchaser/Owner should be immediately informed for any discrepancy in drawings, specifications and instructions in the execution of job before actual execution of particular item having discrepancy.

d) Any item found to be having been executed with poor workmanship then the Contractor shall have to rectify /reconstruct the work as specified by Purchaser/Owner. No extra charge will be admissible in such case. If CONTRACTORS fails to do so, the Purchaser/Owner reserved the right to rectify/reconstruct the work through some other agency at the expenses of Contractor.

e) The schedule of activities as submitted by the Contractor shall have to be strictly adhered to. Regular progress reports shall have to be submitted by the Contractor giving all details for monitoring of the schedule.

f) Special care is to be taken for cleanliness of the site. After the end of day's work, the site should be cleaned immediately.

g) The Contractor shall have to co-operate with the agencies executing other works in the same area.

h) While executing the work, the Contractor shall ensure safety and security of the property of the Purchaser/Owner so as to avoid theft etc.

#### 6) LIQUIDATED DAMAGES FOR DELAYS

If the equipment is not supplied to the purchaser within the time stipulated in the Order, Purchaser may at their option, either (1) recover from the Supplier liquidated damages at the rate of 0.5 % of the total contract value for every week of delay, subject to a maximum of 7.5 % of the total contract value, or (2) at the risk and cost of the Supplier and without prejudice to the other remedies/rights as per the Contract, terminate the order wholly or partially and complete it themselves or reassign it to other Suppliers.

### 7) FORCE MAJEURE

- a. Neither the Supplier nor the Purchaser shall be considered in default in the performance of their obligations as per the Contract so long as such performance is prevented or delayed because of strikes, war, hostilities, revolution, civil commotion, epidemics, accidents, fire, cyclone, flood or because of any law and order proclamation, regulation or ordinance of Government or subdivision thereof or because of any act of God. The proof of existence of force majeure shall be provided by the party claiming it to the satisfaction of the other.
- b. The Supplier shall advise Purchaser initially by a Fax, followed by post, the beginning and end of any of the above causes of delay, failing which Purchaser shall not be liable to consider delays due to the above reasons. Notice as stated above should be given even in case where only the Supplier's bids are under the consideration of the Purchaser and no acceptance of the same has been given and detailed order issued.
- c. In the event of definite delay even if arising out of reasons due to force majeure, Purchaser shall have the right at their discretion to cancel the Order or part of the Order without any liability on their part to make any payment to the Supplier while reserving the right to claim refund of and any payment if advanced or paid to Supplier.

### 8) SETTLEMENT OF DISPUTES

Any disputes or differences or questions or claims arising under or relating to or touching this agreement shall be referred for arbitration to a Sole Arbitrator under the provisions of the Arbitration and Conciliation Act 1996 or any statutory modification or re-enactment thereof for

the time be in force. The award passed by the arbitrator shall be final and binding on the parties hereto.

The contract shall be deemed to have been concluded at Thiruvananthapuram, Kerala and suits and proceedings, if any, shall be only in the courts of competent jurisdiction in Thiruvananthapuram.

The venue of arbitration shall be the place from where the contract is issued.
