### **TERMS & CONDITIONS**

- 1. The Tenderers should be experienced and licensed in both the treatments
- 2. The Party should provide the detailed description of the material, trade name/Chemical name, method of application of the material and concentration of the material dosage quantity during application.
- 3. The party should furnish the material safety data sheet (MSDS) of the material which includes
  - a) Safety precautions during handling.
  - b) Antidote treatment which included the first aid measures, drug therapy, applicable warranty, caution steps.
  - c) Method of handling the materials and its effect on inhalation, skin and oral toxicity.
  - d) Details of Storage conditions and package conditions applicable.
- 4. Reports on Laboratory field trial details including past technical literature has to be submitted by the party.
- 5. The party may also furnish details on environmental friendly measures suggested after application.
- 6. The party should furnish environmental clearance certificate (ECC) of each of the materials used to demonstrate that the materials are not hazardous to Environment.
- 7. The Pesticides having ISI mark only will be used for the treatment.
- 8. The contractor will be fully responsible for the supervision and control of the treatments.
- 9. The prescribed Tender forms can be obtained from the Purchase section from 10AM to 5.00PM on all working days from **21.01.2021**.Last date of receipt of quotations will will be 3.00 p.m on 15.02.2021. The quotations received after the due date will not be accepted or considered under any circumstances.

- 10. The received quotations will be opened at 3.30PM on 15.02.2021.
- 11. The contractor should take necessary Insurance to take care of any eventuality for the persons engaged by them for doing the treatment work.

- 12. The contractor at own cost will bring all materials required for the treatments.
- 13. EMD: Not applicable. Bidder has to submit Bid security declaration as per Schedule H.
- 14. The Statutory payments such as ESI, PF Income Tax, GST etc. as applicable, are to be paid by the contractor.
- 15. The present area for disinfestations is nearly 5300 Sq. ft. This may vary depending on the requirements from time to time. Hence, rate per Sq. ft. should be quoted. For rodent control rate per month and year to be provided. For mosquito control rate per year only to be provided.
- 16.On awarding the contract, an agreement has to be executed in stamp paper worth of Rs.200/-.(Rupees Two hundred only). The agreement draft is available in HR section for reference.
- 17. Incomplete quotation will be rejected summarily.
- 18. The successful Bidder shall deposit 3% of Work order value towards Security deposit.
- 19. Forfeiture of Security Deposit: The security deposit shall be forfeited, in the event of failure on the part of vendor to execute the work during the contract period.
- 20. The company has the right to reject or cancel the tenders without assigning any reason thereof.
- 21. Decision of ED(O) & Unit Chief, HLL-PFT on any dispute or clarification will be final and binding.
- 22. The areas for the treatment can be inspected on all working days between 10AM to 4.00PM.
