- 4. In the event of placing orders: -

In tenderer shall return one copy of order signed and sealed as a token of acceptance.

(i) In case of rejection, the machine should be taken back and replaced at yours risk and cost within 10 days of intimation from HLL.

Machine shall be returned back to you through the Transporter indicated by you.

- A. Certificate confirming that the machine offered by you is environment friendly i.e. non-hazardous to the environment is to be enclosed with the Technical bid.
- B. The supplier agrees to supply strictly as per the order terms in respect of quality and specification. HLL reserves the right not to receive the goods beyond the delivery date given in the order.
- C. The following documents should accompany the consignment

D. Payment Terms :-

5. WARRANTY

The supplier shall warrant that the goods supplied under the contract shall have no defect arising from design, materials or workmanship. Period of warranty shall be 12 months from the date of installation and commissioning or 18 months of supply whichever is less as certified jointly by the supplier and the Purchaser.

6. INSURANCE

7. DELIVERY/COMPLETION PERIOD

10. INCIDENTAL SERVICES
