### **Selection procedure:**

The selection process for the positions of Pharmacist (Grade IV to I), and Assistant Pharmacist comprises of written test and interview.

The written test for all the posts shall comprise of multiple-choice questions which should be answered in 30 minutes' time and the maximum mark for the written examination is 50. There are no negative marks for wrong answers.

### **Age:**

The maximum age limit for applying to the above positions is 37 years as of 01.03.2026

### **General Conditions:**

1. Before applying, candidates should ensure that they fulfil all the eligibility criteria mentioned in the advertisement.
2. Only Indian Nationals are eligible to apply.
3. SC/ST/OBC/PwD candidates will be eligible for relaxation as per Government of India directives.
4. The crucial date for determining the age limit shall be same as the cut of date for calculating Qualification & Post Qualification Experience of the candidates.
5. HLL reserves the right to cancel, restrict, or modify the selection process, or to not fill any or all of the posts notified, at its discretion. The number of vacancies may also be increased or decreased based on organizational requirements.
6. The decision of Management regarding selection will be final.
