However, the particle boards used for fabricating tables/workstation should comply with the detailed technical specification cited in the tender document. 2. Annexure VI BOQ – BOQ1 Modular Furniture – S.No 6.1- Conference Table size shall be referred as 3900mm(L) x 1500mm(W) x 750mm(H). However, other table specification remains same as per tender BOQ. 3.
