C. BID EVALUATION-:

C.1 EVALUATION OF TECHNICAL BID

Bidders who comply with requirements mentioned in B.1 Technical Presentation.

Note:-Vendors may be required to give a **presentation before the technical committee at a given notice**, on their proposed roadmap for the service delivery. Vendor's team shall respond to any technical & operational deployment queries raised by the Purchaser. The purpose of such presentations would be to allow the bidders to present their proposed solutions to the committee and orchestrate the key points in their bids.

The Technical Committee Decision will be final for Technical evaluation of the bidder. **PRICE BIDS of only technically qualified bidders would be opened.**

C.2 EVALUATION OF FINANCIAL BID

The price/financial bid shall be evaluated to find out the L1 considering the total amount payable at the rate quoted by the bidder under **Annexure -1** for all the items.

D. <u>SCOPE OF WORK</u>

The service provider is required to provide services as listed hereunder: **Dedicated Server –:**

- 1. Server Hosted in Data Centres, preferably in India with due security norms & certification.
- 2. High End Multi Core/Multi Processor Servers with Managed Administration, Security, Backups and Upgrades.
- 3. Secure encryption eg. SSL encryption during data transmission/Network security.
- 4. Closely monitored server security with regular security patches.
- 5. Multi redundant Bandwidth Network.
- 6. Scalable bandwidth on demand

- 7. Complete power redundancy.
- 8. Industry-leading customer support available 24/7 via phone or helpdesk.
- 9. Dedicated key Account Manager.

Email Hosting –

1. Hosting should be done on Dedicated Indian Server (Server Hosted in data Centres in India).

- 2. Reliable and trusted email solution, user friendly & comprehensive with all advance features- email forwarders, auto responders, spell check and aliases etc.
- 3. Shared Calendar, Distribution list, and Shared Contacts.
- 4. Instant Activation.
- 5. 500 mail id's which can be extended as per the requirement of HITES.

6. Total storage of 2.50 TB including backup.

7. Email logs & email backup for all the emails must be taken on regular basis and must be provided to HITES, in appropriate format, as and when required.

8. Mails can be downloaded to MS Outlook through mail setup, info which will be provided by hosting provider.

- 9. Anti Spam & Anti Virus Solution.
- 10. The e-mail should be compatible with all leading Web Browsers, viz. IE, Chrome, Mozilla and match the upgradations of the browsers.
- 11. On demand space increment
- 12. (POP3) /IMAP Incoming Server
- 13. (SMTP) outgoing Server
- 14. IMAP/POP3 Mailboxes with enabled password policies.
- 15. Recover messages in Outlook for up to 14 days. Restore and entire deleted mailbox for up to 30 days.

16. Provide lead Security Forensic and investigation information in case of e-mail abuse, security breach, unauthorized access etc.

- 17. Secure Control Panel.
- 18. Any other related works, if required.
- 19. The existing accounts from HLL mail server to the new server, No data to be lost (inbox/send) during transition.
- 20. Customised Mail Log In Page
- 21. Meeting Scheduler thru' e-mail.

E. LIABILITY FOR LABOR AND/OR PERSONNEL ENGAGED BY THE SERVICE PROVIDER

It may be noted that HITES is merely engaging the services for web hosting, maintenance and ancillary services and is not liable for any labour and/or personnel engaged by the service provider. HITES shall be fully indemnified by the Contractor against all the payments, claims and liabilities, whatsoever incidental or direct arising out of or for compliance with or enforcement of the provisions of various labour related Acts or similar other enactments.

F. EXIT CLAUSE:-

Post contract agreement, the arrangement can be terminated by either party by giving 03 months advance notice or charges in lieu thereof. But this option however shall not be exercised by either Party within first term of one year of contract period. During termination of the contract, the agency should provide existing data backup (emailing solution) as per HITES requirement.

G. CONFIDENTIALITY -:

It may be noted that providing Email solution, etc are highly confidential in nature and the disclosure of sensitive information pertaining to any of these to any unauthorized officials / third parties is completely prohibited. No information will be divulged to any one, other than those authorised by HITES to receive such information.

H. OWNERSHIP-:

The HITES shall be the first and exclusive owner of the solution created in this agreement. This does not include the Intellectual Property of pre-existing material (like third party Software, Tools, etc). The customized code of the applications as well as related documentation, developed will be with the HITES, who will retain the right to modify, upgrade and reengineer the complete solution based upon the customized code provided.

I. PERIOD -:

The period of contract for providing Email solution will be for a period of **Five years** from the date of awarding work to the successful bidder. HITES Noida may at its sole discretion to extend/renew further period of one year if required with the same terms and condition.

J. PAYMENT SCHEDULE -:

The agency need to submit the bill to the IT Department, HITES after successfully completion of each quarter and amount shall be paid to the agency within 10 working days from the submission date of the bill.

K. PERFORMANCE GUAREENTEE:- The successful bidder would have to furnish a Performance Bank Guarantee for an amount equivalent to 02 percent of the Total Order Value for 05 Years (excluding taxes & duties)

L. PENALTY:

If the agency fails to either resolve the fault or unable to provide standby solutions in the stipulated time period, penalty shall be applicable as per the decision taken by competent authority/management of HITES.
