TERMS AND CONDITIONS

1. The Bid must be accompanied by EMD of Rs.10,000/- (Rupees Ten thousand) by the way of Demand Draft or NEFT/ RTGS, drawn in favor of HLL Lifecare Limited., payable at Ernakulam. The tender documents can be downloaded from our Website: www.lifecarehll.com. The bidders downloading the tender documents from our website are required to enclose Demand Draft/RTGS for Rs.590/- drawn in favour of HLL Lifecare Ltd., payable at Kochi towards the cost of tender documents, along with the Bid. SSI/MSE units interested in availing exemption from payment of tender fee & EMD should submit a valid copy of their Udyog Aadhar registration certificate. The Tenders not accompanied by the DD for Rs.590/- and EMD without copy of Udyog Aadhar will be summarily rejected.
2. The CHA should have at least 3 years of minimum experience in clearing and forwarding activities in CSEZ as on 31/12/2025. Proof of experience & authorized license details to be attached along with the tender document. The party should have a working office in Ernakulam, who can immediately perform services on need basis.
3. The Contractor should have a valid Service Tax Registration/GST and produce copy of the Registration Certificate to the Company before commencement of the Contract. The party should have valid PAN & Bank Account in any Nationalized (or) scheduled bank. Proof to be attached.
4. The Contractor should have an ICEGATE ID.

13. The Company shall not be liable for the delay in submission of tenders after the due date specified above due to any reason including Postal delays etc.
14. The Unit Chief of Kakkanad Factory, Cochin, reserves the right to cancel or reject the Tender fully or partially, without assigning any reason and his decisions will be final and binding on all Tenders.
15. HLL will have the right to cancel the contract at any point of time, after giving one months' notice.
16. Any blacklisted parties are not permitted to participate in Bids and if submitted will be rejected.
17. All documents attached along with the bid are to be signed and sealed.
18. 25% of annual procurement value will be sourced from Micro and Small Enterprises.
19. The Price bid shall be valid for one year. However, HLL reserves the right to limit/extend the validity period without assigning any reason.
20. (MSE), out of which 4% is earmarked for procurement from MSE's owned by SC or ST entrepreneurs and 3%, is earmarked for procurement from MSE's owned by Women entrepreneurs. In the event of failure of SC or ST or Women entrepreneurs to participate in tender or meet tender requirements/conditions regarding price the same will be sourced from other MSE enterprises.
21. If any information provided in the Bid is found false at any point of time during the contract period, the same shall result in termination of contract, disqualification of the tenderer from future tenders, forfeiture of Security Deposit and payment of compensation towards loss or damage caused to the Company on account of making false claims.
22. The duties related with SEZ are required to pay at Cochin Special Economic Zone by the awarded party, the details to be submitted to HLL. Regarding the details about SEZ related duties the interested bidders may visit www.csez.com. HLL KFC being a CSEZ Unit GST is Zero rated.
23. Forfeiture of Security Deposit: The security deposit shall be forfeited, in the event of failure on the part of contractor to execute the work during the contract period. Further such contractor/s may also be blacklisted / barred from participating in HLL's future tenders for a period of two years.
24. If the awarded party is not taking work within the allotted time frame otherthan any unavoidable circumstances like vehicle strike, natural calamity etc., the contract will be cancelled and the EMD/ Security deposit amount shall not have returned to the party. Then HLL may consider the next lowest party to award the contract at the risk and cost of the original vendor.

27. Preference to Make in India

Preference shall be given to local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a local supplier, should be as per relevant notification / order issued by the nodal ministry as available on the website of Department of Promotion of Industries and Internal Trade (DPIIT). If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted.

Verification of Local Content:

The supplier at the time of tender, bidding or solicitation shall be required to indicate percentage of local content and provide self-certification that the items offered meets the local content requirement for supplier, as the case may be. They shall also give the details of the locations (s) at which the local value addition is made.

In case the bid value is more than Rs.10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 and subsequent amendment dated 16.09.2020 and any other amendments which may be made from time to time and its subsequent Orders/ Notifications issued by concerned Nodal Ministry for specific Goods/Products. Rule 144 (xi) of the GFR regarding restrictions on procurement from a bidder of a which mandates the bidder from a country sharing land border with India Regarding restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
