1. The technical specifications of the item are given below;

- 2. The prices should be quoted as per the format for price schedule enclosed as **Annexure –I.**
- 3. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser.
- 4. The prices quoted shall be valid for a period of 90 (Ninety) days from the date of opening of bids.
- 5. The exact brand/model of all the quoted items should be mentioned with complete technical specifications supported with illustrative literatures/catalogues/broachers.
- 6. The items should be delivered and installed within 2 (Two) weeks from the date of issue of Purchase Order.
- 7. Penalty at 0.50 % of the total Purchase Order value for each week of delay or part thereof subject to a maximum of 5 % is applicable for delayed delivery.
- 8. The bid shall be evaluated by taking the total amount quoted for all the items.
- 9. Necessary user manuals/CDs/DVDs/accessories/License documents are to be supplied along with the items.
- 10. The minimum warranty period (onsite) of the items is 3(Three) Years from the date of installation. All defective HDDs should be replaced at free of cost.
- 11. Installation of SAS HDDs and successful configuration/integration of the same with existing IBM V5000 Storage are purely under the scope of the bidder only with the necessary support from OEM if required.
- 12. Bids should be clear in all respects and those with ambiguous and conditional clauses shall be rejected.
- 13. HLL will have the right to increase or decrease up to 40% of the quantity of goods / services specified in the schedule of requirements without any change in the unit price or other terms and conditions during the validity period

- 15. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.

- 17. The supply order shall be placed on the lowest responsive bidder.

 - b. Delivery/Installation report duly signed by the concerned person of HLL and representatives of the supplier.
 - c. Warranty certificate if any
