TERMS AND CONDITIONS FOR HIRING OF VEHICLESFOROFFICIAL USE ON CONTRACT BASIS

- 1) The tenderer must be the owner of vehicles. The vehicle should be registered after January 2012. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration.
- 2) <u>The bidder should not offer vehicles which are already under contract with</u> other units of HLL or with any other organization.
- 3) An EMD of Rs.5,000/- (Rupees five thousand only) per vehicle by way of Demand Draft favouring HLL Lifecare Limited, Trivandrum payable Thiruvananthapuram should accompany the tender. Tender without EMD will be summarily rejected.
- 4) The rate should be quoted in the enclosed format.
- 5) An amount of Rs.10,000/- is to be remitted as security deposit by the successful tenderer, for each vehicle.
