Terms & Conditions

- 1. The respective bidder should have minimum 3 years' experience in supply, installation and maintenance of Security devices (UTM, Firewall etc.)
- 2. The following documents are to be attached along with bid;
 - a. Certificate of Incorporation
 - b. Self-certificate stating that the bidder has not been blacklisted/ debarred by any institution of the central/state Government/PSU.
 - c. The documentary evidence like supply orders/certificate from the clients for the similar works done for the past three years.
 - d. Copies of documents for PAN, GST etc.
 - e. Manufacturer Authorization Form (MAF) from the OEM of the products
- 3. The prices should be quoted as per the format for price schedule enclosed as **Annexure 1.**
- 4. In the price schedule, if there is any discrepancy between the unit price and total price the unit price shall prevail and the total price shall be corrected by the purchaser.
- 5. The bids will be evaluated by taking the total amount for all the items.
- 6. The prices quoted shall be valid for a period of 90 days from the date of opening of bids.
- 7. The subscription should be provided within **2 (Two) weeks** from the date of placement of order.
- 8. Penalty @ 0.50 % of the total Purchase Order value for each week of delay or part there of subject to a maximum of 5 % is applicable for delayed delivery
- 9. Necessary documentations/CDs/DVDs if any are to be supplied along with the product.
- 10. Statutory documents like licenses if any should be supplied along with the product.
- 11. As our Kakkanadu Factory, Kochi (KFC) can avail tax exemption as it is located in Special Economic Zone (SEZ) and hence the invoice (Nil GST) is to be submitted accordingly.
- 12. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 13. The supply order will be placed on the first lowest responsive bidder.
- 14. During the subscription support period all the defective items (hardware) should be replaced and the periodic updates from OEM should be provided at free of cost.
- 15. Necessary support should be provided as and when required within 2 Hrs of intimation of problem. Telephonic support should be provided at 24x7. However onsite support should be provided if required.
- 16. The bidder who requires any clarification on the tender shall notify the undersigned through e-Mail at <u>sivakumar@lifecarehll.com</u>. However, no post bid clarification shall be entertained.
- 17. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.
- 18. No bidder shall try to influence the Purchaser on any matter relating to its bid, from the time of the bid opening till the time the Purchase order is placed.

19. The validity of existing subscription ends on various dates between the months July and September. Hence the payment will be released separately within 30 days from the date of successful renewal of subscription of the respective NGFW devices installed at different locations.

For claiming this payment, the following documents are to be submitted.

- a) Three copies of GST Invoice
- b) Statutory documents (Subscriptions) if any
- 20. The bids should be submitted at the following address.

If the bid opening day is declared as holiday for HLL, the bid will be opened at the next working day of HLL.
