The following amendment has been incorporated in the above referred EOI No. **HLL/CHO/PSD/MKTG/2024-25/EOI/04 Dt: 04-10-2024** for Empanelment of Suppliers for the Manufacture and Supply of Sanitary Napkins for 60 Months
