### TERMS & CONDITIONS OF TENDER DOCUMENT

- a. Rate offered should be the basic rate. The rates should be quoted in **Annexure -2** attached. The party should have valid PAN, GST registrations, Import-Export Code & Bank Account in any Nationalized (or) scheduled bank & required certificate from Pollution control board. The supporting documents to be enclosed along with the bid.
- b. If the party is in the category of MSME, the supporting documents to be submitted along with the bid to avail the applicable relaxations.
- c. The total payable value is the **total base price with its GST, Customs Duty, Social Welfare Charge, TCS & if any other duties/charges for those items** by the way of DD, drawn in favor of HLL Lifecare Ltd., Ernakulam must be submitted well in advance at HLL, Kakkanad before the clearance of the scrap materials. - c. The quantity for the **entire period of 2023-24** mentioned is approximate only. Intimation will be done when some reasonable (Approx. 2500 Kg) quantity is accumulated. So the payment to be made on actual measurement of that quantity only. The Contractor should arrange for the removal of the available scraps **within 5 (FIVE) days of the phone/email intimation**. The contractor shall take out the scraps on office hours only.
