TERMS & CONDITIONS

1. Rates quoted should be inclusive of labours, materials and all kinds of taxes.
2. Statutory deductions such as Income tax, work contract tax, PF, service tax etc., are applicable as per rules.
3. The tenderer should put his seal & signature on all pages of the tender documents. The tenders without EMD are not acceptable.
4. The rates quoted shall be final.
5. Payments will be made after satisfactory completion of work on actual measurement basis.
6. During execution of work, the Contractor or authorized representative should be present at site.
7. **ACCIDENT & INSURANCE:**
In case of any accident to the labours engaged by the party while executing the work, party shall be responsible for the same and shall pay the compensation as per the WCA and the rates framed thereunder.
Insurance for the labours shall be arranged by the party at their cost as per WCA.
8. The Company reserves the right to reject any or all the tender either partly or completely without assigning any reason.
9. All materials used should be of reputed make and samples should be submitted for approval.
10. Cement used must be ACC/Birla Plus/Ultra tech of 43 graded & above (OPC) brand only.
11. If water and Electricity supplied by HLL Lifecare Ltd. will be charged 1% each on every consumption items.
12. All works to be carried out as per instructions of Engineer-in-Charge.
13. Security deposit @ 10% of total amount of work/ Bank guarantee will be retained for **Ten years**.
14. Before starting the work, the samples of materials to be submitted for approval.
15. The Contractor shall not sublet (sub contract) this work.
16. The doubts, if any regarding work, terms & condition may be got clarified before submission of tender.
17. While executing the work, safety rules are to be strictly adhered. Safety equipments / tools are to be arranged by the contractor only.
18. A penalty will be charged @ **0.5%** on total value of the work to be completed for every delayed week subjected to **7.5%** maximum.
19. All labour & supervisor must wear helmet during execution of all works, when working at heights they must obtain work permit from safety officer.
20. Contractor has to execute Guarantee bond for water proofing treatment for terrace as per our standard format.
